#### Term and conditions:

- The work should be carried out strictly as per the specifications and as per the directions of the Engineer-in-charge.
- Safety measures as specified in CPWD general conditions of contract should be adopted to protect the labour from every risk specifically while cleaning the tank.
- Time allowed for completion of work is 03 days from the date of issue of Work Order.
- 4) The rate shall include the cost of all labour, materials and all the operations involved as described in the specification of item and nothing extra shall be paid on whatsoever account.
- 5) The rate should be quoted both in figures and works which should include all taxes etc.
- The rate should be applicable to all heights and leads and transportation of materials and tools etc.
- 7) The payment shall be made as per actual execution and measurement at site after the completion of the work in all aspects and to the satisfactory level.
- The Income tax shall be deducted as per applicable and notified by Govt.of India.
- In case of delay in completion of the contract, LD at 1/2 percent of the contract value per day of delay subject to the maximum of 10% of contract value/work order will be levied without assigning any reason unless extension is obtained in writing from the office on valid ground before completion date.
