ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, Maulana Azad National Urdu University, Hyderabad, Andhra Pradesh has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Maulana Azad National Urdu University, Gochibowli, Hyderabad-500032. Andhra Pradesh for Secondary(B.Ed-Distance Education) course of two year duration with an annual intake of 500 (Hundred) Students.

2. AND WHEREAS on scrutiny of the application submitted by the University, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Maulana Azad National Urdu University, Gochibowli, Hyderabad-500032. Andhra Pradesh for conducting Secondary(B.Ed-Distance Education) course of two year duration with an annual intake of 500(Hundred) students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:

- i) The University shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- ii) The University will ensure that the core faculty at the Headquarters level should comprise of one Professor, one Reader and four Lecturers are in position for an intake of 500 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
6. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
7. If the University contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
