**Item No.1 :-** Confirmation of the minutes.

a) Confirmation of the minutes of the BoS meeting held on 31.01.2018.

The follow-up action taken on the minutes of BoS held on 31.01.2018 (page No.4 to 16).

b) Confirmation of the minutes of the DRC meetings held on 19<sup>th</sup> -20<sup>th</sup> December,2017 and 16.04.2018 (page No.17 to 33).

The Board of Studies members noted the Action taken Report and resolved to confirm the minutes.

**Item No.2:-** Approval of the re-organized course contents of syllabus to equalize the credits of M.Ed., B.Ed., and D.El.Ed., programmes.

The re-organised course contents of the syllabus of M.Ed, B.Ed., and D.El.Ed. Programmes are placed before the BoS members.

The HoD explained that the re-organised course contents of the syllabi are developed based on conducting a workshop and series of meetings by the faculty in the Department of Education and Training and also considering the applicable suggestions received from CTE-Darbhangha and CTE -Bhopal.

The members of the BoS after thorough discussion with suggestions resolved to consider and approved the re-organized course contents of the syllabi for the M.Ed.,B.Ed., and D.El.Ed., programmes in view of the semester-wise equalization of credits to be offered in each semester from the academic year 2018-19 (page no. 34 to 78).

It is further resolved that in case of B.Ed, (Distance Mode) programme the syllabus shall become effective for 2019-20 batch as it needs time to prepare the Self Learning Material of the re-organised contents.

**Item No.3:-** Any other item

The Principal, CTE-Aurangabad has forwarded agenda items to put up in the BoS.

The BoS members after thorough discussion resolved that

**3.1. The minimum requirement of attendance may be 80% in practical also for B.Ed @ with a 10% grace on medical ground.**

Not to consider in view of NCTE-Regulation,2014



**3.2. Count and display the theory and practical attendance separately on the students' IUMS portal.**

As the matter is pertaining to Centre for Information Technology, the Principal, CTE-Aurangabad has to send a letter to Director. CIT, MANUU to explore the possibilities.

**3.3.CTE may be upgraded to three years B.Ed., M.Ed integrated degree programme.**

The matter pertains to administrative decision.

**3.4.The CTE Aurangabad may be given M.Ed(R) programme.**

Principal should prepare a proposal and forward to the competent authority through proper channel.

**3.5.The CTE- Aurangabad may be given Ph.D (Education) Programme also.**

The CTE-Aurangabad is not a Research Centre of MANUU.

**3.6.To include some of the papers in B.Ed (R) programme.**

The members of BoS thoroughly debated on this matter and resolved to confirm that all the subject are incorporated in the syllabus as a whole.

It is further resolved by the members of BoS that the weightages given in syllabus are keeping in view of the NCTE Curriculum.
