


Prof. Noushad Husain, Chairperson of Board of Studies, Department of Education and Training warmly welcomed all the members of Board of Studies. He briefly explained the Agenda of the meeting which was followed by item wise discussion.

Item No. 1: Confirmation of the Minutes of BoS meeting held on 07.05.2019.

The Minutes of the BoS meeting held on 07.05.2019 were confirmed by all the members.

Item No. 2: Approval for reshuffled structure of B.Ed. programme.

The reshuffled structure of Proposed Semester wise Equalisation of Credits of B.Ed. Programme was placed before the BoS. The BoS members thoroughly checked the reshuffled structure and approved the same.

Item No. 3: Approval of revised Syllabus of Science Education in the Ph.D. programme.

The revised Syllabus of Science Education in the Ph.D. programme was placed before the BoS for approval. After going through the Syllabus, the BoS members approved with a minor addition in point 1.5 of Unit 1: Introduction to Science Education. It is as under:

Old: 1.5: Science Education Policy in Post-independent India:Role of Science Education in sustainable development

Item No. 4: Implementation of 4 years Integrated Teacher Education Programme (ITEP).

The matter regarding implementation of 4 years Integrated Teacher Education Programme (ITEP) was placed before the BoS. After a long discussion the BoS made the following resolutions:

1. The 4 years ITEP Programme (Upper-primary to Secondary) can be started at the Department of Education and Training, MANUU, Hyderabad from the year 2021 as quite a long time is required to design the syllabus of the programme.

2. As there is already shortage of staff in the DE&T, extra staff is needed. There is also the need of additional infrastructure for starting the said programme.

3. At the first stage, 4 years ITEP (Arts stream) should be started at the Department of Education and Training, MANUU, Hyderabad.

Further, the BoS members unanimously agreed that two Committees should be formed for initiating the process of implementation of 4 years ITEP. These Committees shall carry on the work as follows:

Committee 1: The members of this Committee will make survey, study and collect the information (such as the syllabus, requirement of staff and infrastructure) from other educational institutions where the 4 years ITEP has already implemented.

Committee 2: The members of this Committee will study the National Council of Teacher Education (Recognition, Norms and Procedure) Amendment Regulations, 2019. It will decide the requirement of human resources and physical resources for implementing the 4 years ITEP. Thereafter, the Committee will prepare a proposal and submit it to the Chairperson, Board of Studies.

The BoS members authorised Prof. Noushad Husain, the Chairperson to nominate the Committees.

Item No. 5: Any other item with the permission of the Chair.

The BoS members had a partial discussion regarding the revised Syllabus of Teacher Education in the Ph.D. programme. The suggestions of Prof. Faiz Ahmad, Principal, CTE Darbhanga were added in point 3.5 of Unit 3. Therefore, the 3.5 of Unit 3 will be read as Teaching as a Profession: Accountability (*Teacher Appraisal and Evaluation*), Social responsibility and Code of Professional ethics.

The meeting ended with vote of thanks.
