

Prof. H. Khatija Begum, HoD and Chairperson BoS, Department of Education and Training welcomed all the members of the BoS and introduced Prof. A. Rama Krishna, Dean, Faculty of Education, Osmania University, Hyderabad the new External Member to all the members and initiated the agenda items for discussion.

Item No.1: - Confirmation of the minutes of the BoS meeting held on 18.07.2017.

The follow-up action taken on the minutes of BoS held on 18.07.2017 is placed as Annexure-I.

The Board of Studies noted the Action taken Report and confirmed the same.

Item No.2:- Approval of the Almanac of all the programmes offered by Department of Education and Training.

The Almanac of all the programmes offered by Department of Education and Training for the 2<sup>nd</sup> and 4<sup>th</sup> Semester 2017-18 are considered and approved.

Item No.3:- Approval of semes er-wise equalisation of credits of M.Ed., B.Ed., and D.El.Ed., programmes are placed before the RoS

In view of the resolution of the minutes of 29th meeting of the Academic Council held on 12th January, 2018 under the item no. 29.4.15 'Number of Credits and Courses for B. Ed programs to be offered under both Regular and Distance Mode as per NCTE Regulation-2014-Reg. '

The Resolution reads as "The members discussed the matter and suggested that the programs conducted as per regulatory bodies shall adopt the regulations notified by the respective bodies from time to time. Accordingly, the Chairman of the house desired that the School of Education and Training shall prepare the number of credits and courses for B. Ed programs to be offered under regular and distance mode as per NCTE Regulations-2014 which is to be made effective from 2018-19 and ratify the changes suggested by DDE for B. Ed., distance mode program for existing batches of 2015-16 and 2016-17 academic years".

The members of the BoS after thorough discussion considered and approved the proposed semester -wise equalisation of credits and the courses to be offered in each semester for the M.Ed., B.Ed., and D.El.Ed., programmes. This is placed as Annexure-II.

It is also resolved to conduct a one week workshop to finalize the new courses of the syllabus to be offered in each semester from the academic year 2018-19 in the month of March, 2018. do.

## Item No.4: - Any other Item.

i) Eligibility criteria for admission in D.El.Ed for students of Madrasa Board of respective states.

A proposal was received from the Dean, School of education and Training that the students of Madrasas which are affiliated to Madrasa Boards of respective states and who have completed 12<sup>th</sup> equivalent have to join in Bridge course of the university. After completion of Bridge course they need to compete in entrance test for admission in D.El.Ed. The matter is placed before BoS for discussion and consideration.

The proposal presented by the Dean, School of Education and Training thoroughly discussed by the members and resolved to constitute a committee. The committee has to go into the details of the subjects studied by madrasa students of different Boards with reference to the Regulation of D.El.Ed program and the requirement of Elementary Schools.
