In terms of section 15 of the NCTE Act, 1993, the your Institution had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting D.Ed course of 2 year duration with an additional intake of 40 students at Maulana Azad National Urdu University, Gachibowli, Hyderabad 500032, Andhra Pradesh.

2. On the basis of the scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and videography, the SRC in its 173<sup>rd</sup> meeting held on 20<sup>th</sup>-22<sup>nd</sup> April 2009, it is satisfied that the above institution has adequate financial resources, accommodation, library, laboratory as prescribed in the norms and standards and that it fulfills all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course. It is decided to grant Conditional Recognition/Letter of intent for the additional intake of 54% in existing D.Ed course as per reservation for other Backward class (in Central Government institutions) Admissions Act, 2006 for conducting D.Ed course of Two year duration with an annual intake of 115 (One Hundred & Fifteen) students which includes the existing intake of 75 (Seventy Five) students and an additional intake of 40 (Fourty) students from academic session 2009-10.

3. Before grant of formal recognition under regulation 7(11) is considered, you are requested to submit the following:

The institution shall make appointment of additional faculty / staff by a duly constituted selection committee and ensure selection of candidates possessing qualifications as prescribed under rules. After appointment of faculty/staff, Affidavits as under should be submitted.

- Annexure - I - An Affidavit on Rs.100/- stamp paper to the effect that the institution has appointed additional staff as per NCTE/State/University norms.
- Annexure - II - An affidavit on Rs.10/- non judicial stamp paper by all the individual faculty member appointed by the institution and are in position.
- Annexure - III - Details should be filled by every faculty member appointed.

4. The institution shall launch its own website covering, inter alia, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, class rooms and other facilities/amenities), instructional facilities (laboratory, library etc.) and the particulars of the appointed teaching and non-teaching staff etc., with photographs. The details of the website shall be submitted.


5. Before issuance of formal recognition order, the institution should convert the Endowment Fund of Rs 5 lakhs and Reserve Fund of Rs.3 lakhs in to joint account with SRC-NCTE. The form of joint account from a Nationalized Bank shall be sent to this office by post for signature.

6. You are advised to comply the above requirement before formal recognition is considered under Regulation 7(11).

Admissions should not be made until formal recognition order under Para 7(11) of the NCTE (Recognition Norms & Procedure) Regulations, 2007 is issued by the SRC, NCTE and affiliation is obtained from the University/examining body concerned.

The compliance report / reply along with documents as stated above should be submitted within 21 days without fail.

**ORDER**

**WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. **AND WHEREAS**, the institution Maulana Azad National Urdu University, Gachibowli, Hyderabad-500032, Andhra Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.

3. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- (i). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

4. **NOW THEREFORE**, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Maulana Azad National Urdu University, Gachibowli, Hyderabad-500032, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.

5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 12/12/2014

2. AND WHEREAS, the institution Maulana Azad National Urdu University, Gachibowli, Hyderabad-500032, Andhra Pradesh has by affidavit consented to come under New Regulations and sought for one unit in M.Ed which require additional facilities

3. AND WHEREAS on scrutiny it is found that SRC in its 257<sup>th</sup> meeting held during 20<sup>th</sup> 22<sup>nd</sup> December, 2013 Considered the matter and decided to ask the university to clarify 1) Location and building details of 3 Courses 2) Courses wise staff lists indicating subject details 3) Total enrolment is 307 which is excessive of the ceiling of 300 where will they like to reduce? A Reminder letter was issued to the University on 07/11/2014. The revised order issued is subject to the decision of the committee on pending reply of the University

4. AND WHEREAS, it has been decided to permit the institution on Intake of one unit of 50 students subject to the institution fulfilling following conditions namely

- i. The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn
- ii. The institution shall create additional facilities that include (a) additional infrastructure (b) additional funds, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- iii. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved staff list in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- iv. The Regional Committees shall arrange for verification of documents inspection of these premises and check adherence to these conditions by 20 Feb 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee NCTE hereby grants recognition to Maulana Azad National Urdu University, Gachibowli, Hyderabad-500032, Andhra Pradesh for conducting M.Ed programme of two years duration with an annual intake of 50 Students (one Unit) from the academic session 2015-16 subject to fulfilment of the conditions mentioned at 4(i) herein by 31/01/2016.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
