About the Seminar

Social justice and inclusion are indispensable cornerstones of a democratic society. They affirm the values of equality, equity, dignity and human rights that the Indian Constitution enshrines. While India has witnessed significant progress in areas such as education, health and representation of marginalized groups, the persistence of structural inequalities continues to undermine the very ideals of justice. Caste hierarchies, patriarchal norms, religious polarization, economic inequalities and regional disparities have resulted in systemic marginalization of Dalits, Tribals, women, religious and linguistic minorities, persons with disabilities and LGBTQ+ individuals. Many of these Socially and Economically Disadvantage Groups (SEDGs) remain on the periphery of development and nation-building, often excluded from quality education, secure employment, affordable healthcare, political participation and cultural recognition.

Contemporary transformations including rapid urbanization, globalization, technological advances and climate change pose both challenges and opportunities. For example, digital technologies can enable access and empowerment, yet the "digital divide" often reproduces exclusion. Similarly, welfare schemes are introduced to promote social justice, but gaps in governance and implementation limit their reach.

This seminar intends to open up a dialogue that bridges theory, research and practice by interrogating the challenges of exclusion while also envisioning the prospects of inclusion. It emphasizes that social justice is not only about redistribution of resources but also about recognition, representation and equal participation of marginalized voices in shaping India's future. In line with the Sustainable Development Goals (especially SDG-10: Reduced Inequalities) and "Viksit Bharat 2047", the Seminar highlights the urgency of inclusive pathways for sustainable and equitable growth.

In this backdrop, the Al Beruni Centre for the Study of Social Inclusion, Maulana Azad National Urdu University (MANUU), Hyderabad, is organizing a Two-Day National Seminar on "Social Justice and Inclusion: Challenges and Prospects for Marginalized Communities" on February 02-03, 2026.

Objectives of the Seminar

The seminar aims to critically examine the barriers to inclusion faced by marginalized communities in India and to explore the role of law, policy and social movements in advancing social justice. It will highlight pressing challenges such as economic exclusion, cultural stereotyping and the digital divide while providing a platform for scholars, researchers, academics, policymakers and practitioners to share empirical studies and theoretical perspectives. The ultimate objective is to generate innovative strategies and policy recommendations that can foster inclusive and equitable development rooted in dignity and justice.
