BACKGROUND AND RATIONALE

India is witnessing a critical phase in its democratic evolution as it moves towards the centenary of its Independence in 2047. The national vision of *Viksit Bharat 2047* underscores the goals of inclusive growth, citizen-centric governance, technological advancement, and democratic deepening. In this context, strengthening democratic institutions, ensuring electoral integrity, and expanding meaningful political participation are vital for sustaining India's constitutional democracy in the digital age. Issues such as misinformation, fake news, algorithmic manipulation, digital surveillance, data privacy concerns, and unequal access to digital technologies raise critical questions

about electoral fairness, democratic accountability, and institutional trust. These challenges necessitate systematic academic inquiry and policy-oriented discussion.

The digital transformation of democracy has had differentiated impacts across social groups. Marginalised communities—including Scheduled Castes, Scheduled Tribes, Other Backward Classes, religious and linguistic minorities, women, rural populations, and the urban poor—have experienced both new opportunities and continuing exclusions. While digital platforms have enabled access to welfare schemes and political communication, persistent digital divides based on gender, region, education, and socio-economic status continue to shape unequal participation and representation. Understanding how digital governance and electoral processes intersect with social inequalities is crucial for advancing an inclusive democratic framework aligned with the constitutional values of social justice and equality.

Against this backdrop, by bringing together scholars, researchers, policymakers, and practitioners, the seminar seeks to foster critical reflection and constructive dialogue on the future of Indian democracy in the digital age. The outcomes of the seminar will contribute to building a resilient, participatory, and socially just democratic framework, consistent with the constitutional vision and the long-term national aspiration of *Viksit Bharat 2047*.
