## **NOTIFICATION**

The Academic Council(AC) in its 31st Meeting (Emergent) held on 4.6.2018 (vide Resolution No. 31.4.02) considered the recommendations of the Committee, constituted by the Vice-Chancellor to examine the measures for enhancing local representation of students in its Constituent Colleges/Institutions. The Committee was of the view that there should be necessary provisions for preferential treatment for native students in admissions to maintain the equity and diversity.

- 2. The AC took note of the under representation of native students in various programmes being run by the University in its Main Campus and Satellite Campuses. The AC observed that these eventually led to skewed regional equity of students. After deliberations, the AC, *resolved and approved* that a 10% weightage in the entrance test marks shall be provided to 'home state' candidates to a maximum of 30% of approved intake in the following programs from the academic year 2018-19:
  - (i) M.Ed in all CTEs and Department of Education & Training
  - (ii) B.Ed in all CTEs and Department of Education & Training
  - (iii)Diploma in Engineering in all MANUU Polytechnics
- 3. As approved by the AC, the above relaxation shall be subject to the following conditions:-
  - (i) Reservations for SCs/STs/OBCs/PwD/Women shall apply under the above category.
  - (ii) For the purpose of 'home state' category, students who have passed the qualifying examination from any Institution/University or State Board or NIOS's Study Centre located in a particular state where the Institution is located subject to other eligibility conditions prescribed for a programme of study.
  - (iii) The matter shall be reviewed after completion of admissions for 2018-19.
- 4. The Controller of Examinations shall prepare the Merit List of students who appeared in the entrance test held on 26 & 27th May 2018 for the B.Ed, M.Ed and Diploma in Engineering programmes, taking into consideration of above decision of the AC. Further for determining 'Home State' category, the 'domicile State' given by the applicants in the online application will be taken as a base on provisional basis. The Merit list for these programmes shall be under two categories viz. 'All India Ranking' & 'Home State Ranking'. The Counseling will be scheduled accordingly by the Directorate of Admissions. A copy of the said notice may be sent to all applicants who appeared in the Entrance Tests held on 26 & 27th May 2018 for bringing all relevant records including proofs of residence, knowledge of Urdu etc. for availing relaxation under 'Home State' category.
