At the outset, Chairperson of the committee welcomed the members. thereafter Member Secretary appraised about the agenda items to be discussed in the meeting, which are following;

a) Prospectus for the year 2020-21

- The Member Secretary informed honourable members that since UGC-DEB has notified its UGC (ODL and Online Program) Regulations, 2020, hence DDE proposes its prospectus for admission notification for the academic year July 2020-2021. The members agreed on the programs to be offered in this academic year. There are no new programs being introduced in this year.
- The members agreed for the fee revision recommended by Fee Revision Committee. However, the members recommended that the Convocation Fee of Rs.300/- may continue instead of Rs.500/- recommended by the committee, to be charged from the candidates appearing in the final year examination. along with

their exam fees. The members appreciated provision of fee concession to all Women, EWS and Transgender along with SC/ST/PWD.

- After elaborate discussion and legal opinion of the Standing Counsel of MANUU, honourable members agreed for the continuation of B.Ed program for the academic year 2020-21 under semester mode since SLMs are available as per semester mode as required by UGC-DEB Regulations.
- Members suggested that UGC-DEB be informed about the introduction of semester system in B.Ed (DM) program as required by UGC-DEB Regulations.
- Some of the members suggested to incorporate *In-service* clause in second category of eligibility as well for admissions to B. Ed (DM) program as per the Preamble of NCTE B.Ed (ODL) Regulations, 2014, so that there should be complete clarity with dovetailing and synchronization between the two for the benefit of the clientele.
- The members suggested to merge the three eligibility criteria already mentioned in the prospectus in one eligibility criterion for admissions to M.A in languages.
- The members also agreed to recommend the adoption of UGC (ODL & Online Program) Regulation, 2020 dated 4th September 2020 by the Academic Council.


b) Academic Calendar for B. Ed. & other programs.

c) Appraisal of the minutes of the Inquiry Committee meeting in respect of B.Ed. program.

- The Chairperson appraised the members about the inquiry committee recommendations constituted by the competent authority of the University to look into the withheld results of B.Ed distance mode program which is approved by Executive Council of the University.
