### **OFFICE ORDER**

Subject;-Revision of wages of short-term contractual and daily rated employees engaged by the University.

Considering the recommendations of the Committee constituted by the Vice-Chancellor for revision of existing wage structure of short-term contractual and daily rated employees engaged by the University, the Executive Council in its 70th meeting held on 28th June, 2018 has, vide Resolution No. 70.4.5, resolved to revise the existing wage structure of these categories of employees engaged at Main Campus, Hyderabad including Directorate of Distance Education and other outstation offices/ institutes of the University.

The change in nomenclature of short-term contractual / daily rated employees, their categorization, revision in wages and other terms and conditions of their engagement shall be as below:

#### (d) Other Terms & Conditions

The revision in wages of short-term contractual / daily rated employees shall be subject to the following terms and conditions:

- The existing incumbents falling under skilled category as per para 2(b)(iii) shall be (i) entitled to revised wages only after qualifying the skill test conducted by the University in not more than three chances or within a period of six months from the effective date of these orders, whichever is earlier. Till such time they qualify the requisite test, these incumbents shall be treated as unskilled and would be allowed the revised wages as applicable to MTS (Category-I) employees.
  - (ii) The engagement of short-term contractual employees shall be need based and such engagement shall not exceed three months in one spell. Their further engagement shall be subject to their satisfactory performance of the assigned jobs to be certified in the prescribed pro forma by the respective Controlling Officer / Head of the Department.
  - (iii) The salary of short-term contractual / daily rated employees shall be computed on the basis of their attendance generated through bio-metric system when introduced for regular employees.
- 3. These orders shall be effective from 1st July, 2018.
