Resolution:

The proposed syllabus was considered and recommended, after certain changes, for adoption in the proper bodies from session 2018-19.

SUGGESTIONS:

The following resolutions were adopted in the meeting.

- 1- Prof S Z H Jafri suggested to introduce some Non-Indian papers in the M.A programme, so that students can develop a comprehensive understanding of Indian history.
- 2- He proposed the idea that some excerpts from original primary and secondary texts may be made available to the students to inculcate the practice of reading first hand source materials. He specifically emphasized this point with regard to DDE. He also promised to help and contribute to DDE in whatever capacity he could.
- 3- It was resolved that the paper titled "India and Its Central Asian Neighborhood", which is a DSE paper in the existing syllabus, will be offered only in the current academic session 2018-19. The paper, however, will not be offered from the next academic session onwards. Instead, a different paper titled "Economic History of India, 1757- 1964" will be introduced as the Core Paper from the academic session 2019-2020 onwards.
- 4- A Project or "History of Islam in India" will be offered as a Core subject in the regular mode. In the Distance Mode the paper titled "History of Islam in India, 12<sup>th</sup> -20<sup>th</sup> Century" will be offered.
- 5- It was resolved that from now onwards, there will be three DSE papers in the regular mode and distance mode having two options each. The two DSE papers in the third semester of Regular mode include papers titled "Medieval Deccan and Far South"/ "Ancient World" and "Women in Modern India"/ "Religious Traditions in India". The Only DSE paper in the fourth semester of regular mode is "Medieval Indian Numismatics"/ "Medieval World". These very same combinations will be offered in the distance mode as well. However, the paper to be offered in the current session will be notified by the department and DDE at the time of admission/ in prospectus.
- 6- Four new papers were framed in the meeting, while certain important structural and thematic changes were made in the existing two papers.

The four new papers designed are


- 1) History of Islam in India, 12<sup>th</sup> -20<sup>th</sup> Century"
- 2) Ancient World
- 3) Medieval World
- 4) Economic History of India, 1757-1964

The papers in which changes were made include

- 1) Religious Traditions in India
- 2) History of Ideas in Modern India


