The Ph.D scholars of batch 2017 have made PPT Presentation before the DRC members of their synopsis & topics.

Following points were discussed & resolved:

1. Mr. Mohammad Amir's (17PHIS001HY), presentation was appreciated in general. His topic "Environmental Pollution –An Islamic Perspective (ماحولیاتی کثافت اور اسلام)" was approved. He was suggested to make corrections in proof reading as well as minor modifications in sub-heads of chapterization.
2. Ms. Hina Majid (17PHIS001SR, ASCW, Srinagar), made presentation. Her topic was modified and approved as "Environmental Conservation & Islam (محفوظ ماحولیات اور اسلام)". She was advised to re-write /re-arrange her chapterization as per the new approved topic. She was also instructed to mention hypothesis & methodology clearly, and make correction in Urdu words and proof reading of her synopsis.
3. Ms. Qamrun Nisa (17PHIS002SR, ASCW, Srinagar). Minor change has been suggested in her Urdu topic and approved as "Shayakh Hamza Makhdoom Kashmiri's Contribution Towards Socio-Religions Transformation of Kashmir Society: An Analytical Study (شیخ حمزہ کی معذوم کشمیری کی دینی سماجی اور اصلاحی خدمات۔ ایک تجزیاتی مطالعہ)". She was advised to make changes in chapterization and add units under chapters. Some changes have also been suggested in the content of her synopsis.

4. Ms. Mehrul Nisa (17PHIS003SR, ASCW, Srinagar). Her topic as presented " **Relevance of Spirituality in Contemporary world: Special Reference to Buddhism and Islami in Jammu & Kashmir** (معاصر دنیا میں روحانیت کی معنویت: جموں و کشمیر میں بدھت اور اسلام کے حوالے سے) " was approved. She was advised to make minor changes in chapterizations and do corrections in proof reading.
5. Ms. Saleeqa Ashraf (17PHIS004SR, ASCW, Srinagar). Her topic in Urdu was approved as " **Orientalist Approach to Hadith: with special reference to G.H.A Juynboll** " (نقد حدیث اور مستشرقین کا نقطہ نظر: جی۔ ایچ۔ اے۔ جویں بال کے خصوصی حوالے سے) ". She was advised to re-write and re-arrange her chapterization as per the topic, mention hypothesis and methodology and make necessary corrections and proof reading in her synopsis.
