M. Ziyauddin, (both Assistant Professors, Department of Sociology, MANUU, have participated the meeting as internal members and. In this regard the following resolutions are passed;

I. Reporting Items:

1. The minutes of the RAC meeting of research scholars of the department held on 11/05/2021, approving the satisfactory progress of research of all the Ph. D scholars, except Mrs. Afsana, has been reported to the DRC. The members felt that Mrs. Afsana be warned for her unsatisfactory progress of research asking her to be in consultation with the research supervisor and improve her performance and submit the thesis within the stipulated period.

II. Items for approval:

1. Following 14.4.3 and 16.2 of the Ph. D regulations of MANUU to present and submit the synopsis by the research scholars pursuing second semester, before the DRC, Mr. Salim Khan, Mr. Ghulam Zeelani and Ms. Afreen Begum, who enrolled into Ph. D in Nov-Dec 2020, have presented their synopsis of their respective Ph. D topics. The members of the DRC have given certain advises specific to each scholar with regard to improving their synopsis and submitting the same to the department. Accordingly, the scholars will work on the lines of the suggestions made to improve/strengthen their proposal/synopsis incorporating the changes. Also all the scholars were advised to develop both English and Urdu versions of the synopsis and submit it to the department for an onward circulation

2. The item of claim of Non-NET fellowship amount pending for certain period for one Ph. D Scholar, Mr. Hilal Ahmad War, was placed before the DRC which approved the same recommending to release the fellowship for pending months.

Mr. Hilal Ahmad War, a Ph. D scholar enrolled into the department of Sociology in the academic year 2017, is a Non-NET fellowship holder. As he had represented his grievance that he did not receive the fellowship for the months of June19, July19, September 19, November 19, and from January 2020 to July 2020 (Eleven months total), due to the reasons he mentioned in his letter, the department had forwarded the matter to the Dean, Academics, MANUU, who advised the department to place the matter in the bodies like RAC and DRC seeking its recommendations for reviving the fellowship for the months for which it is due. Hence the matter was placed in the DRC meeting of the department held today, 28/06/2021. The DRC has approved the item and recommended to release the fellowship amount to Mr. Hilal Ahmad War for the pending months.
