RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to COLLEGE OF TEACHER EDUCATION, (MAULANA AZAD NATIONAL URDU UNIVERSITY) T.M.HYDERABAD, CONVENT SCHOOL COMPLEX, SULTANIA ROAD, NEAR TELEPHONE EXCHANGE, BHOPAL, MADHYA PRADESH under section 14 (3)A of NCTE Act, 1993 for conducting B.Ed. (URDU) course (100 Intake) vide order No. APW03553/223475 (Urdu)/WRC/5-6/104/2008/37856-37861 dated 29-07-2008.

AND WHEREAS, Revised Recognition order was issued to SHIVAM COLLEGE, LAL BARRA ROAD, WARD NO. 11. KATANGI, BALAGHAT, MADHYA PRADESH, vide order No. WRC/APW03553/223475/2015/147574-147581 dated 31-05-2015for B.Ed. (URDU) of Two Years Duration with an annual intake of 100 students for two basic units of (50 students each) from the academic session 2015-2016.

AND WHEREAS, Compliance was not Submitted as per regulations 2014.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause notice was issued to the institution on 20.09.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order:

AND WHEREAS, the reply of show cause notice was not submitted by the institution.

AND WHEREAS, the matter was placed in 268th Meeting held on February, 09-11, 2017 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"Consideration of cases in which reply of Show Cause Notice issued for compliance of NCTE Regulations, 2014, is not received till date

The list of 43 institutions was put up for considerations. In these cases, Show Cause Notice be issued to the institutions as to why the number of units in the B.Ed. course, which were given by revised order, should not be reduced / reversed.

AND WHEREAS, the Show Cause Notice was issued to the institution on 15.02.2017 and its reply received on 07.03.2017 & 08.03.2017.

AND WHEREAS, the matter was placed in 276th Meeting held on May, 30-31st, 2017 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The case file was seen. The issue refers to the PIL filed Pawan Dubey and inspection conducted under Section 13 by the NCTE Hqrs. Deficiency letter was issued on 28/05/2015 and reply not received till date.

Hence, Show Cause Notice be issued as to why the Recognition should not be refused."

AND WHEREAS, the clarification letter was issued to the institution on 06.06.2017 and its reply received on 20.10.2017.

AND WHEREAS, the matter was placed in 290TH Meeting held on March, 21-23 2018 of WRC and the Committee decided that. "The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The case file was seen. Deficiency letter dated 28.05.2015. The institution did not reply till May 2017. Subsequently, Show Cause Notice was issued on 06.06.2017. The institution has sent a reply in which it has said that till the regular faculty is appointed, they would function with guest faculty, this is not acceptable. The institution has not overcome the deficiencies till date.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

AND WHEREAS, the clarification letter was issued to the institution on 26.03.2018 and its reply received on 24.04.2018.

AND WHEREAS, the matter was placed in 301st Meeting held on January,17-18 2019 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 20.09.2016 followed by Show Cause Notice dated 15.02.2017, 06.06.2017 and Compliance letter dated 26.03.2018 were issued.

The institution in its reply dated 24.04.2018 has not submitted the staff list approved by the competent authority.

The institution is required to submit latest staff profile in the prescribed proforma duly approved by the competent authority in original.

Hence, Compliance should be submitted by the institution within one month."

AND WHEREAS, the clarification letter was issued to the institution on 24.01.2019 and its reply received on 25.03.2019.

AND WHEREAS, the matter was placed in 310th Meeting held on August,19-212019 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"The compliance letter was issued to the institution vide letter dated 24/01/2019. and reply received on 20/03/2019.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

On perusal of the reply of the institution the committee observed that in-spite of earlier 3 opportunities to submit approved staff list for intake of two units, the institution is failed to submit the same.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, the Withdrawal order was issued to the institution on 05.09.2019.

AND WHEREAS, the institution filed an Appeal to the Council on 03.11.2019 and the Council vide its order dt. 13.10.2020 remanded back the case to the WRC, NCTE for necessary action and accordingly the institute submitted related documents in WRO vide letter dt 14.08.2020.

AND WHEREAS, the matter was placed in 329thMeeting held on 17-19thFebruary 2021,of WRC and the Committee decided:

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

 The institution is required to submit latest Staff list duly approved by the Registrar of the concerned affiliating body clearly indicating the seal and signature of the Registrar along with faculty approval letter issued by the concerned affiliating body.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 14 of the NCTE Act for B.Ed. programme.

AND WHEREAS, the Final Show Cause Notice was issued to the institution on 11.03.2021, and its reply received on 16.06.2021.

AND WHEREAS, the matter was placed in 344th Meeting held on 08-09 October 2021 of WRC and the Committee decided that.

"This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the Institution for B.Ed course be restored."

NOW THEREFORE, recognition dated 29-07-2008 and revised recognition order dt. 31.05.2015 issued to the institution viz COLLEGE OF TEACHER EDUCATION, (MAULANA AZAD NATIONAL URDU UNIVERSITY), URDU T.M. HYDERABAD CONVENT SCHOOL COMPLEX, SULTANIA ROAD, NR. TELEPHONE EXCHANGE, BHOPAL, MADHYA PRADESH for B.Ed. course is hereby restored permitting the total annual intake of 100 (two units of 50 students).
