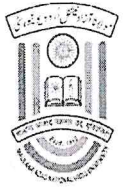

At the very outset the Dean SE&T Prof. Siddiqui Mohd. Mahmood extended heartfelt welcome to all the members. The following items were reported in an emergent meeting of the School Board and resolved.

Item No. 1: Confirmation of the minutes of the last School Board meeting held (1) on 27th April, 2022 and (2) meeting on 12th May, 2022.

The Chairperson highlighted the main points which had been discussed in the last School Board meetings held on **27th April, 2022** and **12th May, 2022** and the Minutes were circulated through email to all the members and no observations/comments have been received. The members confirmed the Minutes.

Item No. 2: Approval of Minutes of Board of Studies of Department of Education and Training held on 12.08.2022.

While presenting the minutes of Board of Studies, Dept. of Education & Training the chairperson School Board Prof. Siddiqui Mohd. Mahmood, discussed the salient features of proposed rules/norms with regard to Maternity Leave for the women students along with the condition that Medical Certificate submitted by the women student should be of "Govt. District Medical Officer or Govt. Primary Health Centre Medical Officer". The School Board members resolved the same. It was also resolve to clarify the matter of extending the duration of the programme for 4 years for such students from NCTE.

Item No. 3: MOOCS courses that may be taken by the students/scholars in the Department of Education and Training.


The Chairperson School Board informed that some courses have been identified from the SWAYAM platform for the students of the following programme. They are in accordance with the credits as prescribed by our syllabus.
