The Executive Council was informed that Prof. Ghanta Ramesh a senior Professor of Education of Kakatiya University, Warangal retired on superannuation 31.07.2013 and later on, he was appointed as Professor, Dept. of Education & Training in Maulana Azad National Urdu University, Hyderabad on re-employment basis w.e.f 19.12.2013. He served in MANUU till attaining age of 65 years and was relieved from the services on 07.07.2018.

In order to utilize his expertise, a proposal has been received from the Dean, School of Education & Training to consider appointment of Prof., Ghanta Ramesh as Honorary Professor, keeping in view of his earlier association in MANUU, with his vast experience as he had contributed a lot for the overall development of Dept. of Education & Training and was played a vital role for getting NCTE recognition for the Colleges of Teacher Education of the University spread over in the Country.

The Executive Council after due deliberations approved the proposal of the Dean, School of Education & Training and **resolved** to engage the services of Prof. Ghanta Ramesh as Honorary Professor in the School of Education & Training for a period of one year or till he attains the age of seventy (70) years whichever is earlier as per UGC rules.
