Item No. Status of Outstanding Audit Observations 50.08

The members noted the same.

The Registrar apprised the Finance Committee about the status of outstanding Audit Observations and further informed that the replies to outstanding Audit Observations have been submitted to the office of the Principal Director of Audit (Central), Hyderabad and the efforts are being made to settle the observations.

The members noted the same and suggested to expedite to settle the observations.

Item No. Status of filling up of backlog vacancies 50.09

The status of filling up of backlog vacancies of the University was placed before the Finance Committee.

The members noted the same.

Item No. Reporting of laying of Audited Annual Accounts of the University for the year 2021-50.10 22 before both the Houses of the Parliament

The Finance Committee was informed that the Audited Annual Accounts of the University for the year 2021-22 together with the Audit Report and replies of the University thereon were forwarded to the Ministry of Education, Government of India for placing the same before both Houses of the Parliament as stipulated in Sub Section (4) of the Section 30 of the University Act. The audited Annual Accounts 2021-22 were placed before Lok Sabha and Rajya Sabha 27-03-2023 and 29-03-2023 respectively.

The members noted the same.

Item No. Revised Budget Estimates for the year 2023-24 under Salary, Recurring Grant and 50.11 Capital Assets

The Revised Budget Estimates of the University for the year 2023-24 under Salary, Recurring Head and Capital Assets as submitted to UGC was placed before the Finance Committee for ratification.

The Finance Committee ratified the same.

Item No. Annual Accounts of the University for the year 2022-23 along with SAR for 50.12 consideration

Annual Accounts of the University for the year 2022-23 have been audited by the officials of Principal Director of Audit (Central), Hyderabad in July/August, 2023, the Separate Audit Report (SAR) was received by University on 18-10-2023.



With regard to the Audit observations, the Members suggested to take suitable action wherever necessary, in general and suggested the following in particular:

- 1) Ref No.OBS-874531: The funds deposited with the work executing agency like CPWD, may be considered as the expenditure of the University irrespective of the amount claimed by the contractor.
- 2) Ref No.OBS-873730 and Ref No.OBS-873724: The UGC/Ministry of Education does not issue any authorization/confirmation towards grants payable to the University in case of deficit. The deficit is taken into consideration in the budgeting for the following financial year.
- 3) Ref No.OBS-873180: The suggestion of the Audit may be accepted.

As per the Statutory provision under Section 30 (4) of the University Act, a copy of the Annual Accounts together with Separate Audit Report (SAR) has to be submitted to Government of India to be placed before both the Houses of Parliament.

In compliance to the above provisions of the University Act, the Committee recommended the Annual Accounts to be placed before the Executive Council of the University. After approval by the Executive Council, the Annual Accounts shall be sent to the Ministry of Education for placing the same before both the Houses of Parliament. The Finance Committee recommended the Annual Accounts and the SAR to be placed before Executive Council.

Item No. Any other item with the approval of the Chair 50.13

No other item was placed before the Finance Committee.

The Chairman and Members appreciated the efforts put by the Finance Officer and his team for placing the Audited Annual Accounts 2022-23 before the Committee within the stipulated time to comply with statutory requirements of placing the same before both the Houses of the Parliament.
