

ESOLUTION-6: The members of the BoS appreciated the proposal of collaborative activities with search Centres and Departments at MANUU to promote interdisciplinary research and learning. It was animously resolved that the Head of the Department may go ahead on his discretion to collaborate with it only the Research Centres and Departments at MANUU but also with academic and research based stitutions across India and abroad.

GENDA-7: Any other items with the permission of the Chair.

ESOLUTION-7: With the permission of the Chair, following items were discussed and resolved.

- a. The Head of the Department has brought to the notice of BoS the need of separate social media accounts, handles and pages for the Department of Political Science, MANUU, Hyderabad on Facebook, Twitter, LinkedIn, Instagram and other social media platforms to highlight the activities of the Department and digitally connect with the academia across the world. The BoS considered the proposal and approved the same.
- b. Dr. Md. Khurshid Alam has brought to the notice of BoS about the post-facto approval for the additional paper titled, Research and Publication Ethics (PHCC104CCT) to be taught to the PhD students in Semester-I as part of the Course Work from 2020-21 onwards. HoD informed the BoS

that since the paper is already been considered by the School Board and the Academic Council and also been offered during 2020-2021, it may be approved by the BoS along with its Syllabus prescribed by the UGC. Prof. Mehtab Manzar suggested that the Department may also consider for organizing a Seminar on Research Ethics for the benefit of Research Scholars. After detailed discussion, it was resolved that the *Research and Publication Ethics (PHCC104CCT)* paper may be approved along with the syllabus prescribed by the UGC. The BoS also unanimously resolved to organize a Seminar on Research Ethics as proposed by Prof. Mehtab Manzar.

- c. It was also resolved that faculty may come out with edited books in Urdu on courses offered by the Department with the contributions of Chapters from faculty and research scholars.
- d. The Head of the Department has brought to the notice of BoS about the shortage of teaching staff and the increased workload of faculty. He has also highlighted that the Department is experiencing huge difficulty in smoothly conduct its classes and other research, curricular and co-curricular activities. The HoD proposed that since there are positions of Professors and Associate Professors remain vacant over the years as either candidates did not apply despite regular advertisements or candidates not-found suitable by the Selection Committees, the positions may be converted to general or another category as per the rules and convention so that the vacancies may get filled and the Department may get required teaching staff to run its activities smoothly.

The BoS has considered the proposal of HoD and resolved that the University may convert the reserved positions to general or other category as per the rules and established convention followed by other Universities, advertise the positions and fill the vacancies to meet the requirement of the Department. It was also resolved that if it is not possible immediately then the University may appoint teaching staff on contract/adhoc/temporary against the vacant positions so that the teaching and research activities of the Department of Political Science is not compromised.

The meeting was concluded with the vote of thanks proposed by Dr. Shabana Farheen.
