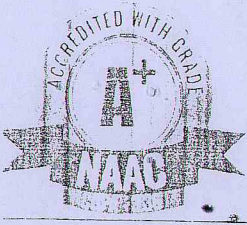

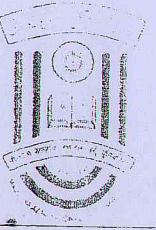
Item No. 1:-

Resolution :- Ms. Tahseen Sultana, bearing enrolment no. 1202020102/A161429 took admission on 12.03.2013, in Ph.D Public Administration. She has completed her 5yrs on 12.03.2018 and as per old UGC Regulations she has availed 1st extension Vide No. MANUU/Dean(SA&SS)/2018/2506, dated 30.07.2018 from 11.03.2018 to 11.03.2019. 2nd extension vide Letter No. MANUU/Acad/F.26/2019-20/231, dated 18th November, 2019 from 12.03.2019 to 11.03.2020 and 3rd extension vide letter No. MANUU/Acad/F.E9/2019/2019-2020/404, dated 6th March 2020 from 12.03.2020 to 11.03.2021.
