<u>Department of Women Education</u> <u>Minutes of BOS meeting (Online Circulation Based held on 18-11-2024)</u>

- 1. A single agenda circulated through email to all the members of BOS- Following is the Agenda item.
- Approval of revised FYUG(Women's Studies) Course Structure (For Skill Enhancement Course (SEC) Papers).
 - 2. It is to clarify that earlier BOS meetings was conducted on 13.07.2023 & 13.08.2024 respectively, to discuss and approve the FYUG(Women's Studies) Dual major Course Structure & Women's Studies Syllabus. The same has been discussed and approved, in the said BOS meetings.
 - 3. Later, a discrepancy in SEC papers was identified by the member of concerned High Power committee regarding the Course Structure which was rectified after discussion and a revised model for SEC papers has been prepared and circulated by the committee.
 - 4. In this regard, a meeting of School Board, School of Arts & Social Sciences, was held on 5th September, 2024 to discuss the FYUG Skill Enhancement Course(SEC) revised structure. The Dean, SA & SS placed before the members the clarification sought from the administration regarding the discrepancies related to the SEC in the format provided earlier by the University for the FYUG (Dual Major) program. As per the clarification provided by the University, each Major Course (Group A & Group B) requires 2 SEC courses, each worth 2 credits, to be completed over 2 semesters.
 - 5. It was proposed to group Majors into two categories based on the semester scheduling for SEC courses:
 - Group A (Major 1): SEC courses to be conducted in odd semesters (1st and 3rd Semesters)
 - Group B (Major 2): SEC courses to be conducted in even semesters (2^{nd} and 4^{th} Semesters).
 - 6. As per the revised format provided by the university and the decision taken in the School Board meeting, the Department of Women Education conducted a DWESC meeting on 17-10-2024 to redesign the FYUG course structure for SEC papers.
