100.5.9. To consider pre requisite mandatory condition for starting of ITEP programmes as a "Multidisciplinary" institution.

The Executive Council was informed that, the MANUU intends to apply for Integrated Teacher Education Programme (ITEP) at 3 Centres i.e. College of Teacher Education, Bhopal, Darbhanga and Srinagar which were stand alone institution and at a new CTE at Varanasi for 2025-26. As per mandatory condition, all these institutions have to convert to "Multidisciplinary" institutions. Accordingly, the University has to offer UG courses in Humanities / Social Sciences and Arts Stream from the Academic year 2024-25 as a precursor before applying for ITEP.

MANUU was offering 3 years UG programmes in Science, Arts & Social Science and Commerce streams. The University has implemented NEP 2020 and started offering UG courses in 4 year Honors / Research mode (4YUG) from 2023-24 in Science, Arts & Social Science and Commerce streams in Hyderabad Campus.

Now, the University intends to commence 4 year UG programmes in Humanities, Arts & Social Science at Model School-Hyderabad (as Evening College) and at CTE-Bhopal, Darbhanga, Srinagar, and Varanasi from the Academic year 2024-25.

The Executive Council after due deliberations resolved to approve the proposal of the University to commence 4 year UG programmes in Humanities, Arts & Social Science at Model School-Hyderabad (as Evening College) and at CTE-Bhopal, Darbhanga, Srinagar, and Varanasi from the Academic year 2024-25. The EC noted that the commencements of aforesaid programmes from the Academic year 2024-25 are as a pre requisite condition to apply for Integrated Teacher Education Programme (ITEP).

Suggestions and appreciation made by the Hon'ble members of Executive Council vis-a-vis introduction of Law School as well as other new programmes initiated by the University.

- a) Prof. Geeta Bhatt appreciated the initiatives of the University for starting Integrated Law programmes, ITEP programmes and other such programmes in demand. She expressed, that there is a huge demand of Law Courses in the Country and MANUU under the leadership of the Vice-Chancellor and in conformity with the norms of Bar Council of India (BCI) is going to start various courses in law. She mentioned that MANUU will find distinct place in India by introducing law courses as it has a good campus which will be added advantage to the students from all over the country. She conveyed her best wishes for introduction of Law and ITEP courses in MANUU.
