**BoS-H-3:** Urdu exemption because of Urdu admissions becoming very less (Annexure-3)

**M. A Hindi and Ph.D Hindi**

- 1) Since Department of Hindi offering PG and above higher studies courses, students from Non-Hindi background only applies for the M.A Hindi and Ph.D Hindi through direct mode. Applying compulsory Urdu subject rule to them will make lot of hurdles at the time of admission process. Because of this rule we are getting very less number of applications every time.
- 2) In South India, because of three language policy, student can opt either Hindi or Urdu as second language, at Degree level. Due to this reason if student opt Urdu as a second language is not eligible for M.A Hindi.
- 3) Because of compulsion of Urdu, most of the students are not interested to apply M.A Hindi in MANUU.
- 4) Because of Urdu compulsion rule student opting other Universities except MANUU, in Hyderabad.
- 5) Department of Hindi established in MANUU, for the purpose of promoting Hindi in Non-Hindi region. Because of Urdu compulsion, Department is unable to fulfill the above mentioned purpose.
- 6) Hence, Urdu condition may be removed to the students of M.A Hindi and Ph.D Hindi.
