Initially Prof. S. Maqbool Ahmed, Nodal officer of B.Voc. Welcomed all the members and the following agenda items were discussed and resolved

5.1. Approval of Minutes of 4th BoS Meeting:

As per the 4th BoS Minutes one new UG course (B.Voc.ETT) was approved to start from the academic year 2024. as such no member raised questions on 4th Bos Minutes, so it is considered to be approved

5.2. M.Voc. MIT & MLT 3rd & 4th Sem Syllabus Approval:

Already 1st and 2nd Semester M.Voc. MIT & MLT syllabus was approved in the 4th BoS meeting, now the committee approved the syllabus of 3rd and 4th Semester M.Voc. MIT & MLT.

- 5.3. Minor Changes in 1st & 2nd Sem of M.Voc. MIT & MLT of existing Syllabus Approval**
As there was a need to make some minor changes in the curriculum of 1st and 2nd Semester M.Voc. MIT & MLT, so it was discussed & few minor changes in the existing syllabus of 1st and 2nd Semester were done.
- 5.4. New UG Course (Emergency & Trauma Care Technology (ETT) Approval of Curriculum**
All the board members thoroughly discussed the curriculum of B.Voc. ETT 1st and 2nd Semester and approved the proposed syllabus. Later Dr. Thayalan suggested to go through the curriculum of Dr. MGR University and advised to take approval of Entire three years syllabus instead of taking semester wise syllabus.
- 5.5. New PG Diploma Course (Post Graduate Diploma Nuclear Medicine Technology (PGDNMT) Approval of Curriculum**
With regards to starting of PG Diploma in NMT all the members were not satisfied to start this course from this academic year due to constrains in taking approvals from AERB. Some members said that this course consists of more than 16 Lab experiments (approved syllabus AERB) & for performing the lab equipments are not available at the university. As per AERB these 16 experiments are compulsory component of PG course hence needs to be establish lab in the initial stage later to start the course. Further some of the members suggested to have multiple MoUs with Nuclear Medicine facility Hospitals / Universities before starting the course. Dr. Thayalan & Dr. Kumarasen suggested to start UG course in Nuclear Medicine before starting PG course. Taking approvals from AERB is time taking factor so starting PGDNMT course was kept in abeyance for some more time.
- 5.6. Approval of Bio statistics& Research Methodology Paper Syllabus for B.Voc. (MIT & MLT) & M.Voc. (MIT & MLT)**
The syllabus of Bio-statistics& Research Methodology was formulated by the Department of Mathematics in consultation with the faculty of Allied Health & Vocational Sciences & this syllabus was approved
- 5.7. Pursuing Internship from any other industry (Hospital) within city and out side city besides MoU Hospitals**
All the BoS members agreed to send students to other than MoU Hospitals
- 5.8. MoU with Omega Hospital**
Recently School of Sciences had MoUs with Omega Hospital for 2023 batch students of UG & PG this matter was reported infront of the committee members.
- 5.9. Approval for Establishment of Separate Department of Allied Health & Vocational Sciences**
As there is a growth in the Allied Health & Vocational Sciences by introducing new courses so it become pertinent to have separate department or centre of Allied Health & Vocational Sciences for its smooth functioning. A separate proposal to establish separate Department or Centre in Allied Health & Vocational Sciences should be formulated & forwarded to UGC for approvals.
- 5.10. Any other matter with the permission of chair**
One of the faculty member had suggested to start B.Voc. in Cardiac Care Technology course in Allied Health & Vocational Sciences. As it was already approved in 4th BoS meeting but due to time constrains the proposal of Cardiac Care Technology is postponed and proposed to take up in the coming session 2025 along with Nuclear Medicine and other courses.
