Item No. 1

Synopsis Presentation by PhD Scholars: English & Comparative Literature (2024 Batch).

Item No. 2

Item No. 3

Request for Cancellation of PhD Admission: Ms. Bushra and Towfeeq Farooq.

The Committee considered the requests for cancellation of PhD admission submitted by Ms. Bushra and Mr. Towfeeq Farooq. After due deliberation, the Committee approved the requests.

Item No. 4 Request for Online Completion of Doctoral Dissertation by Ms. Shirin Akbarian.

The Committee noted that the request submitted by Ms. Shirin Akbarian for online completion of her doctoral dissertation could not be accepted, as her admission had already been cancelled in accordance with the decision made in the 10^{th} DRC Meeting and approved in the 20^{th} Board of Studies (BoS). If the Review Committee finds the evaluation satisfactory and approves, it is recommended that the Head of the Department of English, Prof. Kottacheruvu Nagendra, be assigned to supervise the scholar.

The DRC considered and approved the requests.

Item No. 7

Renewal of the Non-NET Fellowship of Mr. Waseem Ahmad Khan (21PHEN001SR), 2021-22 Batch, Srinagar Campus.

The Committee resolved to constitute a review committee to assess the academic progress of Mr. Waseem Ahmad Khan, in light of his request for a change of supervisor. It was further decided that the request for renewal of the Non-NET Fellowship may be approved and forwarded, subject to a favourable recommendation by the Review Committee.
