101.1. Confirmation of Minutes of 100th Meetings of the Executive Council held on 10.05.2024.

The Registrar informed that the Minutes of 100^{th} EC dated 10.05.2024 were circulated to all the Members of EC and as no comments have been received from the Hon'ble Members, the EC considered and approved the Minutes of the 100^{th} Meeting of the Executive Council held on 10^{th} May, 2024.

101.3.5. Renaming of Directorate of Distance Education (DDE) as Centre for Distance and Online Education(CDOE).

The Executive Council ratified the decision taken by the Vice-Chancellor to change the nomenclature of "Directorate of Distance Education" (DDE) to "Centre for Distance and Online Education" (CDOE) in order to meet the requirement of Distance Education Bureau, UGC for offering programmes in ODL/Online mode. The University issued Notification dated 24.07.2024 for change of nomenclature of "Directorate of Distance Education" (DDE) to "Centre for Distance and Online Education" (CDOE). The Executive Council noted the suggestion of Finance Officer I/c for getting visitors assent for amendment of Act and Statutes of the University. Accordingly, the EC authorized VC to forward a request letter to Ministry of Education through SAMARTH Portal for getting visitors assent for amendment of Act and Statutes of the University for change of nomenclature of "Directorate of Distance Education" (DDE) to "Centre for Distance Education" (DDE) to "Centre for Distance and Online SAMARTH Portal for getting visitors assent for amendment of Act and Statutes of the University for change of nomenclature of "Directorate of Distance Education" (DDE) to "Centre for Distance Education" (DDE).

Further, the EC authorized VC to forward a request letter to Ministry of Education through SAMARTH Portal for getting visitors assent for amendment of Statute 39 of the Statutes of the University.



101.3.6. To report the recommendations of the Committee constituted to review the upper age limit for the regular employees of MANUU in direct recruitment.

101.4.3. To consider the resignation tendered by Dr.A.M.Qadeer Khwaja, Assistant Professor - Islamic Studies, Centre for Distance and Online Education, MANUU

Ref: Item No.100.1.9 of 100th E.C. held on 10.05.2024

The Executive Council was informed that, as per the decision of the Executive Council at its 100th meeting held on 10.05.2024, a Show Cause Notice dated 19.06.2024 was issued to Dr.A.M.Qadeer Khwaja, Assistant Professor - Islamic Studies, Centre for Distance and Online Education stating that why not disciplinary action shall be initiated against Dr.A.M.Qadeer Khwaja Assistant Professor - Islamic Studies, Centre for Distance and Online Education as per rules for absenting himself without sanction of leave beyond 31.03.2024 and his duties w.e.f. 01.04.2024 be treated as "dies non" under FR-17A.

The EC further informed that in reply to the Show Cause Notice dated 19.06.2024, Dr.A.M.Qadeer Khwaja through email dated 26.06.2024 forwarded his resignation stating that he is unable to depart from Madinah to join office at the end of his Extra Ordinary Leave on 31.03.2024. He further states that the situation for him was difficult and he could not leave his father unattended as no other arrangement was possible at the time. Unfortunately, the position continues to be the same. Therefore, he has requested the University authorities to consider his resignation.

The Executive Council after due deliberations considered the resignation tendered by Dr.A.M.Qadeer Khwaja Assistant Professor - Islamic Studies, Centre for Distance and Online Education w.e.f. **26.06.2024**. Further the period of unauthorized absence from 1st April, 2024 to 25th June, 2024 shall be treated as "**Dies-Non**" (i.e. not on duty) for all purposes.

101.4.4. To consider the Extra Ordinary Leave sanctioned to Mr.Kondi Vinay Kumar, Post Graduate Teacher, MANUU Model School, Darbhanga

101.4.5. To consider the amendment in existing Statutes 11 in the Maulana Azad National Urdu University Act, 1996 (No.2 of 1997) for 2nd Court of MANUU.

The Executive Council was informed that the term of 1st MANUU Court has been completed and the University has written a letter to the Ministry of Education to nominate 04 members of the Visitors nominee for 2nd MANUU Court. The names of the Visitors Nominee for 2nd MANUU Court is yet to be received from the Ministry of Education.

The Executive Council further informed that the University got permission from the BAR Council of India to run the Law courses under MANUU LAW School. Upon receipt of the recognition from the BAR Council of India, the University started new law courses from the current academic session and as per requirement, Dean for MANUU Law School was appointed. As per Statute 11 of the Statutes of the University, the strength of the MANUU Court is 30 (Thirty) members including (07) Dean, School of Studies as members of the Committee. Upon appointment of Dean, MANUU Law Page 10 of 20

School, the strength of Dean, School of Studies, MANUU shall be 08 (eight). If Dean, MANUU Law School is included in the 2nd MANUU Court, the strength of MANUU Court exceeds 30 members. Therefore, the University proposes to amend Statute 11 of the Statutes of the University for MANUU Court. Accordingly, following amendment is proposed:

Instead of "All Dean, School of Studies" the University proposes "Seven Dean, School of Studies by rotation basis". Accordingly, Statute 11 of the Statutes of the University needs to be amended.

The Executive Council after due deliberation resolved to *approve* the proposal of the University to amend the Statute 11 of the Statutes of the University by amending "All **Dean, School of Studies**" to "Seven Dean, School of Studies by rotation basis". Accordingly, the EC authorized VC to forward a request letter to Ministry of Education through SAMARTH Portal for getting visitors assent for amendment of Statute 11 of the Statutes of the University.

101.4.6. To consider the amendment in existing Statutes 12 in the Maulana Azad National Urdu University Act, 1996 (No.2 of 1997).

The Executive Council was informed that the Ministry of Education through its letter dated 20.08.2024 requested all the Central Universities to include the Secretary (Higher Education), Ministry of Education, Government of India or his/her nominee as ex-officio member of the Executive Council. Therefore, the Ministry of Education requested all the Central University to take necessary steps to amend the Statutes of the University to include the above representative from the Ministry as a member of the Executive Council.

The Executive Council further informed that as per the existing composition of the Executive Council of MANUU, no official from the Ministry of Education is represented in the Executive Council of MANUU. Therefore, the University proposes to amend the existing Statutes 12 in the Maulana Azad National Urdu University Act, 1996 (No.2 of 1997) by including the Secretary (Higher Education), Ministry of Education, Government of India or his/her nominee as member of the Executive Council.

The Executive Council after due deliberation resolved to *approve* the proposal of the University to amend the existing Statutes 12 in the Maulana Azad National Urdu University Act, 1996 (No.2 of 1997) by including the Secretary (Higher Education), Ministry of Education, Government of India or his/her nominee as ex-officio member of the Executive Council. Accordingly, the EC authorized VC to forward a request letter to the Ministry of Education through SAMARTH Portal for getting visitors' assent for amendment of Statutes 12 in the Maulana Azad National Urdu University Act, 1996 (No.2 of 1997).



101.4.7. To consider the recommendations of the Committee constituted for the implementation of House Building Advance (HBA) Rules in the University

The Executive Council was informed that, the UGC vide letter dated 9th February, 2024, requested all the Registrars of Central Universities to implement Grant of House Building Advance (HBA) as per the 7th CPC to the University Teaching and Non-Teaching Staff. Accordingly, the University vide office order dated 15.03.2024 constituted a Committee for the implementation of House Building Advance (HBA) Rules in the University. The Committee submitted its report together with salient features to the competent authority of the University for its consideration.

The Executive Council after due deliberation resolved to *accept* the recommendations of the Committee constituted for the implementation of House Building Advance (HBA) Rules in the University. Accordingly, the EC authorized VC to take further steps to implement the House Building Advance (HBA) in the University.

101.4.8. To consider the recommendations of the Campus Development Committee for allotment of land on long lease for setting up HPCL Retails outlets for the sale of Petroleum products like MS (Petrol) and HSD (Diesel):

The Executive Council was informed that the University received a proposal from HPCL for allotment of Land for long lease for setting up HPCL Retail outlet for sale of Petroleum products like MS (Petrol) and HSD (Diesel). The said proposal forwarded to the Committee constituted for Campus Development, Maintenance and overall Development of MANUU Campus. The Committee submitted its recommendations for consideration of the competent authority of the University.

The Hon'ble Vice Chancellor informed the Executive Council that the University is planning to introduce its own Medical College in the University. To introduce a Medical College, the University needs 100 Bed Hospitals. The VC further informed that presently, every inch of the University land is important and priceless and can be utilized for future plans. Therefore, after due deliberation, the EC resolved to *defer* the recommendation of the Committee constituted for Campus Development, Maintenance and overall Development of MANUU Campus.

101.4.9. To consider the proposal of the Head, Dept. of Sociology for appointment of Visiting / Honorary Professor at Department of Sociology.

The Executive Council was informed that, the Head, Department of Sociology proposes to appoint Prof.M.Imbrahim Alladin, Adjunct Professor, Cape Breton University, Nova Scotia, Canada as Visiting / Honorary Professor at Department of Sociology keeping in view of his vast experience in the field. The Head, Dept. of Sociology also informed that Prof.M.Imbrahim Alladin will arrange his TA expenses at his own level as this



involves international expenses. Therefore, the University will not bear international air travel expenses.

The Executive Council after due deliberations *resolved* to appoint Prof.M.Imbrahim Alladin as Visiting Professor at Department of Sociology, MANUU as per the UGC rules and regulations and University will not bear any national/international air travel expenses during his tenure.

101.4.10. To consider the proposal of establishment of Satellite Campus at Varanasi (Uttar Pradesh) and to start ITEP programmes at Varanasi Campus.

Ref: Item No.100.5.9 of 100th E.C. held on 10.05.2024

The Executive Council was informed that, with the approval of the Executive Council of the University at its 89th meeting held on 05.02.2022, the University established its Sub-Regional Centre (SRC) at Varanasi. Now, in order to cater the needs of Urdu population located in Purvanchal area from Lucknow to Patna and surrounding districts where more than 250 Madarsas exists and in the larger interest of the students, the University proposes to set up new Satellite Campus at Varanasi (Uttar Pradesh) and to start Integrated Teacher Education Programme (ITEP) programmes.

The Executive Council further informed that, the Executive Council of the University at its 100th meeting held on 10.05.2024 has accorded approval to start new CTE at Varanasi. In order to implement NEP 2020, the University intends to start ITEP programmes at a new CTE at Varanasi from the Academic year 2025-26.

Prof.Farida Siddiqui requested the EC that Darbhanga campus of MANUU may also be made as Satellite Campus as the said campus has its own College of Teacher Education, Polytechnic, Regional Centre, Model School, ITI/VTC, Hostels for students across 26 Acres of land.

The Executive Council after due deliberations resolved to *accept* the proposal of the University to set up new Satellite Campus at Varanasi (Uttar Pradesh) and to start Integrated Teacher Education Programme (ITEP) programmes and also *resolved* to consider and declare Darbhanga Campus as Satellite Campus.

101.4.11. To consider the proposal of the University to allow the Students of MANUU Model Schools (Urdu Medium) at Hyderabad, Darbhanga and Nuh to write their AISSCE & AISCE Examinations in Urdu Medium.

The Executive Council was informed that the CBSE in its 139th Governing Body Meeting has decided to disallow students from writing board exams in any language other than Hindi & English and that the answer scripts written in any language other than Hindi and English without board's permission would not be evaluated. The EC also informed that ever since the affiliation, the University had been receiving question papers of AISSE & AISSCE examination for all subjects in Urdu Medium until 2019.

Thereafter, a communication was received from CBSE Regional Office stating that from the next academic year i.e. from 2020, Urdu Medium question papers would no longer be provided and our students would be required to deal with English / Hindi medium question papers only. However, the concerned subject teacher was allowed to visit the exam centre as a translator for 10 minutes to translate the terminology from English to Urdu till the academic year 2022. After 2022, teachers were denied permission to visit the exam centre for translation. In 2023, despite that the translator was not provided, students wrote their answer in Urdu Language and the same were evaluated by the CBSE Authority.

The EC also informed that the decision of CBSE is against the spirit of the NEP-2020 which unequivocally focuses on multilingualism and the use of familiar language for learning until at least Grade-5 but preferably till Grade-8 and beyond. It is also learnt that question papers in Urdu are provided in Delhi Region Urdu Medium schools. Therefore, a letter dated 25.09.2024 was sent to the Chairman, CBSE, New Delhi by the Vice-Chancellor stating that question papers be provided in Urdu Medium in line with the Delhi based Urdu medium to our MANUU-Model Schools also.

The Executive Council noted the decision taken by the University in the above matter.

101.4.12. To report the communication received from AICTE regarding CAS matters of Humanities and Sciences Faculty of MANUU Polytechnics

Ref: Item No.94.4.14 of 94th E.C. held on 22.05.2023

The Executive Council was informed that the University through a letter dated 27.12.2023 sought clarification from the AICTE, New Delhi regarding promotion (Career Advancement Scheme - CAS) of faculty members of Humanities & Sciences (Diploma) under AICTE, Regulations. The AICTE, New Delhi through letter dated 31.05.2024 forwarded the reply to the clarification sought by the University.

The VC informed the EC that the cases of promotion of faculty of MANUU Polytechnics appointed under Humanities & Sciences subjects have been pending for a long time. From the date of their appointment to till date no promotions were given to them due to lack of clarification / no proper justification in the AICTE (Diploma) Regulations for Humanities & Sciences faculty.

The Executive Council after due deliberations *resolved* that the cases of faculty of Humanities & Sciences subjects of MANUU Polytechnic be considered under AICTE (Diploma) Regulations and *one time relaxation* may be given to them to consider their promotion cases at par with UGC Regulations where Refresher / Orientation Courses are allowed beyond their assessment period till December, 2024. Thereafter, their promotion cases shall be dealt with AICTE (Diploma) Regulations only.



101.4.13. To consider the renaming of Al-Beruni Centre for the Study of Social Exclusion and Inclusive Policy (ACSSEIP) as Centre for the Study of Social Inclusion (CSSI)

The Executive Council was informed that the UGC vide letter dated 29.07.2024 changed the nomenclature of "Al-Beruni Centre for Study of Social Exclusion and Inclusive Policy" (ABCSSEIP) to "Centre for the Study of Social Inclusion" (CSSI) and requested all the Central Universities to implement the same.

Prof.Shugufta Shaheen, OSD-I requested the EC that the name of Al-Beruni be included while changing the name of Al-Beruni Centre for Study of Social Exclusion and Inclusive Policy (ABCSSEIP) to Centre for the Study of Social Inclusion" (CSSI).

The Executive Council after due deliberations resolved to rename the Al-Beruni Centre for Study of Social Exclusion and Inclusive Policy" (ABCSSEIP) as "Al-Beruni Centre for the Study of Social Inclusion" (ABCSSI) in order to implement the UGC directions received through letter dated 29.07.2024.

101.4.14. To consider the proposal for appointment of Prof.Syed Imtiaz Hasnain, Professor of Sociolinguistics, Aligarh Muslim University, Aligarh as Adjunct Professor at School of Languages, Linguistics and Indology, MANUU.

The Executive Council was informed that Prof.Syed Imtiaz Hasnain is an Eminent Professor of Sociolinguistics, Aligarh Muslim University, Aligarh and having more than 30 years of Teaching and Research experience was appointed as Chair-Professor, Maulana Abul Kalam Azad on tenure based upto 31.03.2024. The UGC has not extended the term of Chair-Professor, Maulana Abul Kalam Azad beyond 31.03.2024. Therefore, the term of Chair-Professor, Maulana Abul Kalam Azad concluded on 31.03.2024.

The VC informed the EC that the University needs Chair-Professor, Maulana Abul Kalam Azad for three more years. The University will write a letter to UGC requesting them to extend the term of Chair-Professor, Maulana Abul Kalam Azad for three more years.

In the meantime, the University proposes to appoint Prof.Syed Imtiaz Hasnain as Adjunct Professor at School of Languages, Linguistics and Indology, MANUU as per the Guidelines issued by the UGC for Empanelment of Adjunct Faculty in Universities and Colleges.

The Executive Council after due deliberations resolved to appoint Prof.Syed Imtiaz Hasnain as Adjunct Professor at School of Languages, Linguistics and Indology, MANUU as per the Guidelines issued by the UGC for Empanelment of Adjunct Faculty in Universities and Colleges.

Prof. Geeta referring to Item No. 101.4.6 which was about the amendment in the Statute-12 of MANUU Act, 1996 (No.2 of 1997) proposed by Ministry of Education to include Secretary, MoE as Member of Executive Council. She told that, whenever there is a change in the status of the Statues, proposing new amendments, the assent of the Visitor is required and the same shall have to be published in Gazette of India.



The University shall follow-up with the Ministry to amend the changes in the new Statutes. The Registrar informed that the University will follow up with the Ministry for amending the proposed amendment is Statutes of the University which duly were approved by the Executive Council in this meeting as well as previous meetings.

- 2. The unfortunate incidence of financial irregularities found in the Finance Department. The main reason for the said irregularities is basically due to shortage of Non-Teaching staff and she also said that this kind of work/responsibilities shall be given to a permanent employee who can be accountable and responsible towards their jobs. Contractual employees may not be entrusted to deal with financial matters directly in future. She requested the Hon'ble VC to look into the suggestions. The VC welcomed the suggestions of Prof.Geeta Bhat and assured that the University will review the staff of the Finance Section and permanent employees will be entrusted with the responsibility to deal with financial matters directly in future.
- **3.** Prof.Geeta Bhat welcomed the proposal of the Hon'ble Vice Chancellor to establish its own new Medical College in the University. The move of the University will boost the thought of the University and doctors are coming to the University from various fields.
