ORDER

WHEREAS, College of Teacher Education, MANUU, Kamran Millat High School Complex, Chandapatti, Darbhanga, Bihar-846001 was granted recognition for B.Ed. Course with an annual intake of 100 vide Order No.6804 dated 05.03.2007, followed by revised recognition order dt.31.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, as per decision of the ERC taken in its 278th meeting held on 16th – 17th January, 2020, the recognition to B.Ed. course was withdrawn from the academic session 2020-2021. Accordingly, withdrawal order issued to the institution on dt.01.02.2020.

3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order dt.01.02.2020 of ERC. The Appellate Authority vide order No.89-110/E-158610/2020 Appeal/ 16th Mtg. – 2020/ 31st August, 2020/93537 dt.22.09.2020 decided that appellant university is required to submit to ERC within 15 days of the issue of appeal order a detailed list of faculty in the prescribed format duly approved by the Registrar of the University. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

4. **AND WHEREAS**, the ERC in its 286th meeting held on 25th–26th November, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 22.09.2020 and Committee decided to issue a Show Cause Notice to the institution. Accordingly, Show Cause Notice was issued to the institution on dt.09.12.2020.

5. **AND WHEREAS**, in response of the Show Cause Notice institution submitted its representation dated 09.12.2020, 18.12.2020, 21.12.2020 and 31.12.2020. The ERC in its 289th meeting held on 15th February, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to Show Cause Notice and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (Two Units) be issued.

6. **NOW THEREFORE**, recognition withdrawn vide order dated 01.02.2020 to the institution viz. College of Teacher Education, MANUU, Kamran Millat High School Complex, Chandapatti, Darbhanga, Bihar-846001 for B.Ed. course is hereby restored with total annual intake of 100 (Two units).
