Minutes of the DRC Meeting held on 19-07-2024

The Alberuni Centre for the Social Exclusion and Inclusive Policy held its Departmental Research Committee (DRC) meeting at 3:30 pm on 19.07.2024. The Committee has discussed the Agenda items and following resolutions were made:

Agenda 1: Confirmation of the Minutes of previous DRC meeting held on 13-02-2024

Resolution: Discussed and Confirmed

Agenda 2: Seeking approval from the University Competent Authorities regarding the allotment of research supervisors/co-supervisor's from the School of Arts and Social Sciences as per the Centre, to supervise the PhD Scholars of Centre for the academic year 2024-25

Resolution: Agreed to communicate with the Competent Authority for getting approval for taking the eligible faculty members from DDE, SA&SS, and other Departments/Centres as per the Clause No. of 16 (Allocation of Research Supervisor- 16.1 to 16.5 of the Regulations for the PhD Programme of MANUU, 2023) for undertaking the research supervision of the PhD students of the Centre.

Due to the shortage of faculty members in the Centre, a special approval needed for the Centre, being an interdisciplinary/multidisciplinary centre to appoint the faculty members of other Departments/Centres/DDE to accord permission to allot research supervision for the eligible faculty members, particularly as per the Clause 16.5 of PhD Regulations of 2023.

It is also approved in the DRC that taking Adjunct Faculty from the School of Arts and Social Sciences, MANUU for research collaboration and PhD Supervision (as per Prof. Sukhadev Thorat suggestion)

Agenda 3: Changing the name of the Centre from Al Beruni Centre for the Study of Social Exclusion and Inclusive Policy to "Centre for the Study of Social Inclusion" as per the UGC Public Notice/Order, No:F.No.1-8/2016(CPP-II) (C.No.100245), dated 12th July 2024.

Resolution: It has been brought into notice of the DRC that as per the UGC Public Notice/Order, No:F.No.1-8/2016(CPP-II) (C.No.100245), dated 12th July 2024 the name of the Centres will be changed to "Centre for the Study of Social Inclusion".

DRC made a suggestion that a communication need to be sent to the MANUU administration to officially change the name of the centre from "Al Beruni Centre for the Study of Social Exclusion and Inclusive Policy" to "Centre for the Study of Social Inclusion" and the same information regarding the change of the name should be communicated to the UGC.

Agenda 4: Request to be made to the University administration to form Advisory Committee for the Centre at the earliest.

Resolution: Discussed and Confirmed. It has been in pending for a long period and a request to be made to the administration to form a new Advisory Committee at the earliest.

Agenda 5: Centre to focus on as per the suggestion made by the Secretary and Joint Secretary of the UGC for the Centre to focus on the research areas/ New Initiatives such as Urban Poverty/Migration, Child Labor, LGBTQs, Women and other marginalized communities.

Resolution: Discussed and Confirmed. To add Further DRC suggested that Centre should emphasis more on the inclusionary policies to fill the exclusionary gap and to become bridge between Government bodies and beneficiaries. Further the DRC recommended that the Centre should give more attention on bringing awareness on the areas such as Financial Literacy, Climate Change and Disaster Management and its effects of on Women and Children.

Agenda 6: Request to be made to the University administration to fill up all the vacant position in the Centre.





Resolution: Request has been made to the University administration to fill up the vacant position in the Centre.
