**Item No. 49.02.01: MANUU, CUET Prospectus for the academic year 2024-2025 for admission into UG Programmes offered through Regular mode.**

**Item No. 49.02.02: Introduction of Master of Legislative Laws (LLM) - 1 Year and Doctor of Philosophy of Law**

The Academic Council noted the introduction of Doctor of Philosophy in Law from the academic year 2024-2025 and also introduction of Master of Legislative Laws (LLM) -1 Year, without any additional investment in terms of infrastructure and library requirements. #### **Item No: 49.02.06: Conduct of Re examination of Internal assessment and Semester End Examination for the programmes offered at Law School.**

The Academic Council noted the following exemptions to the first batch students for the programmes offered by MANUU Law School. However it is not to be set as a precedent in the future and is to be considered as a onetime measure.

- i. The students who have not secured 40% marks in the internal assessment and are debarred in the end semester examination of Nov – Dec 2024 were permitted to appear in the odd semester examination. Such students were given a special chance to re-appear in the failed internal components. However their end semester scripts shall be evaluated subject to passing of the internal assessment with at least 40% marks.
- ii. The students recommended by the Dean MANUU Law School who could not appear in the ongoing end semester examination due to the 66% attendance cutoff but meet the 65% attendance (and possess overall attendance of 70% in all subjects) as per rule 12 of the Bar Council of India were allowed to give re examination after the completion of the odd semester examination 2024.

#### **Item No: 49.02.07: Change of name of Al Beruni Centre for the Study of Social Exclusion and Inclusive Policy to Al Beruni Centre for Study of Social Inclusion.**

The Academic Council noted the change of name of Al Beruni Centre for the Study of Social Exclusion and Inclusive Policy to Al Beruni Centre for Study of Social Inclusion (ABCSSI) as per Office Memorandum issued by UGC dated 12<sup>th</sup> July 2024 with regard to continuation of UGC schemes during the financial year 2024-2025. **Item No. 49.03.04: Issues related to Admissions:**

- a) The Academic Council ratified the release of second list of admissions for Ph.D. Programmes by overruling the condition of obtaining 50% marks in the Ph.D. interview for qualifying. It was also resolved to consider 50% in aggregate (Entrance Test plus Interview) as mandatory to be eligible for admission in Ph.D. Programme.
- b) One seat to be reserved for each Model school (i.e) Hyderabad, Darbhanga, Nuh in B.Tech. and B.A. LLB 5 year Programme.
- c) The conversion of seats reserved for SC, ST, OBC, EWS etc. to General category shall be applicable exclusively to B.A.,LLB (Hons) and LL.B 3 year Programme only if no eligible candidate is available in the merit list of the concerned reserved category. However, while converting the seats, any unfilled seat(s) reserved for ST Category shall first be offered to SC Category and vice versa and only if no eligible candidate is available, the conversion of the unfilled reserved category seats to the General Category shall be effected. If a seat reserved for Persons with Disabilities remains unfilled due to non- availability of eligible PwD candidates(s) under respective category, the same shall be offered to the candidates of respective category from which horizontal reservation has been provided.
- d) To commence B.A. programme at Varnasi Campus, CTE Darbhanga and CTE Bhopal from the academic year 2024-2025 with an intake of 30 seats at each Campus.
- e) To permit Ms. Hina Alam, Research Scholar, A212591, Roll No.21PHZYF01HY Ph.D. under Self Financing programme in Zoology, School of Sciences to submit Ph.D. thesis.

The Academic Council considered to introduce B.Tech. in Civil Engineering in self-finance mode under School of Technology with single batch/intake of 60 students with existing infrastructure and including the services of regular and contractual faculty/staff working at engineering workshop and Polytechnic, Hyderabad subject to they primarily discharging their regular duties of teaching (theory, practical, and administrative).

The contractual faculty members/staff shall be recruited as and when required as per the AICTE Guidelines and the University norms.

The honorarium/remuneration and other expenditures shall be met from the tuition fee collected from the students admitted in B.Tech. Civil Engineering (self-finance mode). The Academic Council also clarified that there should not be any financial implication on MANUU.

**Item No.49.04.14: Conduct of Ph.D. entrance test for Engineering stream by the Department of CS & IT.**

The Academic Council considered to conduct the Ph.D entrance test for Engineering stream in the Department of CS&IT as NET/JRF conditions are not applicable in Engineering Stream. The Entrance Exam shall be conducted by the Office of Controller of Examinations in the same pattern as the Ph.D Entrance of other Courses. The Candidates of M.Sc.CS/IT or Computer Applications with valid NET/JRF are also eligible for admission without entrance test.

III) Programme Project Report Diploma in 'Digital and Social Media' in Online Mode.

Introduction of Diploma in Digital and Social Media and to tie up with the Institutions and Media Houses at all India level for training purposes for the students of Digital/Social Media. The PPR is considered.

VI) Programme Project Report for Diploma in Urdu in ODL Mode.

Introduction of Diploma in Urdu in ODL Mode and the syllabi should be the same for both the regular and distance mode students. The proposed Diploma shall be equivalent to one of the Urdu Subject offered at 10<sup>th</sup> standard and shall be offered by CDOE for both regular and distance mode students in ODL /Online Mode. The PPR is considered.

V) Self-Learning Material (SLM) for B.Ed. (ODL) Program.

The Self-Learning Material (SLM) for all 4 semesters of the B.Ed. (ODL) program has been meticulously developed in alignment with the Guidelines of the UGC-DEB. The SLM is designed to cater to the academic and pedagogical needs of distance learners, provide high-quality content and activities to support self-paced learning. It includes comprehensive modules, assignments, and practical activities, covering all core, elective, and practical components of the program. The SLM has been structured to meet UGC-DEB's quality benchmarks, ensuring compliance with regulatory standards. It shall be made available in both printed and digital formats for the convenience and accessibility of learners. The SLM is considered.

VI) Annual CIQA Report for 2023-24

The Annual CIQA Report for the year 2023-24 is considered.

VII) Introduction of 4 Year UG (4YUG) Programme from 2025-26 in ODL Mode.

The Academic Council considered the proposal of the Director, CDOE that one more year is needed for adopting 4-year UG Programme at CDOE as it takes time for preparation of quality SLM/E-LM as per standard norms of UGC-DEB Regulations, 2020 and PPR approval, SLM approval from Statutory Authorities i.e. CIQA, Academic Council. Presently the permission to run 3 years UG programme is till 2025-26 for B. Com, 2026-27 for B.A. and 2027-28 for B.Sc. programme. Hence, after completion of the SLM writings and statutory approval, 4 year UG from the academic year 2025-26 shall be implemented.
