The Moot Proposition of the Competition will revolve around the Law of Contract. However, the participants will be expected to explore different dimensions of law and not restrict themselves to the theme of the Competition. The School of Law, Maulana Azad National Urdu University proudly presents its Inaugural National Moot Court Competition, focusing on the dynamic realm of Contract Law. This premier competition seeks to engage law students in complex legal scenarios that reflect the evolving landscape of contractual relationships in our digital age. All of which witnessed significant participation of law students from all over India. Keeping up with the spirit of mooting, this year as well, we are delighted to organise our flagship event in hybrid mode.

# MOOT COURT PROPOSITION

## True Justice Foundation v. Republic of Hindora & FinTrack Solutions Pvt. Ltd.

The True Justice Foundation has filed a writ petition before the Supreme Court of Hindora, challenging the legality and constitutionality of FinTrack Solutions Pvt. Ltd.'s data collection and sharing practices. The case alleges that FinTrack, under the guise of enhancing user experience and ensuring national security, has engaged in invasive data collection policies that infringe upon the fundamental right to privacy guaranteed under Article 21 of the Hindoran Constitution. The petition further implicates the Ministry of Internal Security, alleging collusion with FinTrack to exploit user data for political gain, particularly during Hindora's general elections. According to investigative reports by the Hindora Truth Network, FinTrack provided real-time user data to the Ministry, which was allegedly used to influence voter behavior in key constituencies. These allegations have raised serious concerns about the erosion of privacy rights and the misuse of technology for political ends.

The case has sparked widespread public debate, with citizens demanding greater transparency and accountability from both corporate entities and government agencies. While the recently enacted Data Security and Privacy Ordinance, 2023, introduces stricter regulations for data collection and sharing, it has been criticized for its limited scope and inability to address past violations. The petition highlights the need for comprehensive legal and institutional reforms to protect citizens from data exploitation and to establish clear boundaries for data sharing between private entities and the state.

The True Justice Foundation's petition seeks several key remedies, including an independent investigation into the allegations of data misuse, directives to the government to frame robust data protection laws, and measures to ensure that privacy rights are not compromised by technological advancements. The petition also calls for judicial clarification on the scope of the right to privacy in the context of digital platforms and big data. This case presents an opportunity for the Supreme Court of Hindora to reaffirm the importance of privacy as a fundamental right and to set a benchmark for safeguarding individual freedoms in the digital era. As the nation grapples with the challenges posed by rapid technological growth, the outcome of this case will have significant implications for the future of data privacy and the relationship between the state, corporations, and citizens in Hindora.

### ISSUES

1. Whether FinTrack Solutions Pvt. Ltd.'s data collection and sharing practices under the TrackSmart feature violate the fundamental right to privacy guaranteed under Article 21 of the Constitution of Hindora.

2. Whether the Government of Hindora's alleged use of citizens' financial and location data to influence electoral outcomes amounts to an abuse of power and breaches constitutional principles of free and fair elections.

3. Whether the lack of retrospective applicability in the Data Security and Privacy Ordinance, 2023, renders the legislation ineffective in addressing past violations of citizens' privacy.

4. Whether the consent mechanism employed by FinTrack satisfies the legal standards of informed and voluntary consent in the context of digital services.

5. What remedial measures, including judicial directives or statutory reforms, are necessary to ensure accountability for past privacy breaches and prevent future violations in Hindora's digital ecosystem.

Students pursuing their Ph.D. or Diploma courses are not eligible for participation. A recognized College / Institution / University is entitled to send a maximum of 1 team to the competition. Each team shall comprise a minimum of two members and a maximum of three members. Teams shall not disclose their identity or that of their institution. However, the speakers can disclose their names only to the bench during the oral arguments.
