Procedure for Conduct of Online Certificate Verification and Online Interview for Ph.D. (Social Exclusion & Inclusive Policy)

- 1. The qualified candidates shortlisted for Ph.D. online certificate verification are required to upload the following certificates from 11th July to 15th July, 2024 through their application ID credentials on the Admission portal https://manuucoe.in/regularadmission/
 - a. *Proof of Urdu as a subject/language or as a medium in 10th/12th /Graduation or equivalentMadarasa courses with Urdu as medium of instruction approved by MANUU.
 - b. *Marks sheet of 10th/SSC/equivalent Board Examination.
 - c. Marks sheet of 12th/equivalent Board Examination.
 - d. *Marks Sheet of Graduation.
 - e. *Marks Sheet of qualifying examination-Post Graduation.
 - f. Transfer certificate (from the Institution last studied).
 - g. Migration certificate (from the Institution last studied).
 - h. *Valid Category certificates SC/ST/OBC/EWS (format prescribed by Government of India) ifapplicable.
 - i. Bonafide/Character certificate (from the institution last studied).
 - j. *Proof of Exemption from appearing in ET for those who have qualified UGC/CSIR JRF.
 - k. *Copy of research proposal.
 - 1. *PowerPoint presentation of research proposal (6 to 8 slides).

Note:* Mandatory as relevant.

- 2. While uploading the certificates, selected candidates are required to update their contact phone number and email through which they would log in for online Interview.
- 3. The Head of the Department along with a Verification team, constituted by HoD, would access the student's data and verify the uploaded certificates on 16th July, 2024. After certificate verification the team would approve the candidates eligible for interview and, in case of any clarification required, may contact the student to do so with the telephone number provided.
- 4.On scheduled verification date, i.e., between 16th July, 2024 the candidates are required to be alert and respond to any clarification sought by the Department Verification team.
- 5. In case of non-mandatory certificates time would be given for submission till 10th August, 2024.
- 6. The Ph.D. Interview schedule will be micro planned by the Department, i.e., hourly schedule of allotment of candidates which would be intimated to eligible candidates through their registered email. Kindly avoid logging in and waiting through the entire process of Interview.
- 7. The online meeting login would be shared to all eligible candidates through e-mail by 6.00 pm one day before the Interview.
- 8. All the candidates appearing for online interview are required to have proper bandwidth and stable internet connection preferably to Laptops/Desktop/Smartphone so that they can share their Research Proposal Presentation.
