





**The Idea of a University for 21<sup>st</sup> Century  
Maulana Azad National Urdu University**

Looking at the present trend of the exigencies in several educational processes, at college and university levels, where the stress is primarily given on the applied aspects of knowledge, many scholars and educationists are pondering over the possibilities of alternative approaches to education, particularly at the tertiary level. Some of them are reflecting over the possibilities of holistic education.

There is a need to widen the vision of our perceptions. Against this theoretical background the MANUU should formulate its programme of Inter-disciplinary Studies and Integrated Research, which envisages to organize, commission and participate across the disciplines in Urdu language and literature, comparative literature, social sciences, philosophy, comparative religions, linguistics, modern sciences and culture studies encompassing the social sciences and the humanities with the deepest concern for the relations between the scientific, cultural, corporate and political communities. This would be commensurate with the new realities of the 21<sup>st</sup> ~~century~~ important and necessary function of MANUU, at this challenging moment in the changing world order, will be to become a centre which can help interpret Indian knowledge systems with intercultural exchange with other Western cultures, and for greater understanding of India's needs, pre-suppositions and aspirations. It will associate eminent scholars from within India and abroad with the execution of the collaborative research projects. While doing this, we are assuming a proactive role of engaging in various educational, research and training activities in the service of society.

We, thus, envision the MANUU as a hub of scholarship and an agent of cross-cultural studies. We envision it to;

- a) promote collaborative interdisciplinary research projects,
- b) initiate cross-cultural dialogues through seminars and workshops, and joint research programmes,
- c) arrange to have scholars-in-residence for varying periods of time from various institutes/nations,
- d) deliberate on the implications of new technologies, economic and trade and management policies,
- e) promote courses in the language and literature of many nations, particularly of the European as well as Asian continent,
- f) provide ambiance and facilities for social and scholastic meeting with informed citizenry at large, and
- g) to take up contemporary concerns of institution building and practice and voluntary action. In sum, we envision the MANUU to be an independent scholastic centre of advanced studies in Urdu medium of instruction.

- On the BillDesk webpage, the name of the university, Maulana Azad National Urdu University, and the applicable fee payment amount are displayed by the system. The payment amount cannot be modified by the candidate.
- The form fee is accepted through online payment methods only.
- The payment gateway offers four (4) payment options, as listed below:

## 1. University Profile

Maulana Azad National Urdu University (MANUU) is a Central University, established by an Act of Parliament in 1998 with all India jurisdiction. The headquarters and main campus of MANUU is in Gachibowli, Hyderabad. It is spread over 200 acres. MANUU is recognized as a major higher education service provider across the remote areas of the country in Urdu Medium through its regular and distance mode programs. MANUU commenced with distance education programs in 1998 and consolidated its academic and research programs in 2004.

The University is named after Maulana AbulKalam Azad, a scholar par excellence, a prolific writer, an inimitable orator, a gallant freedom fighter, a visionary of the post independent Indian education system and an architect of technical and scientific education in Independent India.

Presently, MANUU is in the process of consolidating the existing institutions, while expanding it to reach the unreached through various intervention measures. Further, to meet the rising aspirations of its youth in general and Urdu speaking community in specific, the University is making considerable progress in all fronts of academics, research and governance with specific vision, mission and objectives.

### 1.1 Vision

To provide access to quality education through Urdu as medium of instruction, while adhering to the inclusive policy.

### 1.2 Mission

To empower socially, economically, educationally and culturally marginalized sections of the society, so that they are brought into the mainstream, and thereby contribute to the socio economic development of the nation through formal and non-formal modes of educational delivery.

*The objectives of the University as per Section 4 of MANUU Act, 1996 (No.2 of 1997) are:*



- *to promote and develop the Urdu language;*

- utilize the resources effectively and optimally and also to transform the University into a Smart, Digital and Clean campus with specific action driven initiatives.



## 1.4 Academic





The Departments are currently offering 115 programs (31 Ph.D.; 31 PG; 17 UG, 09 Diploma and 27 PG Diploma programs and Certificate courses). The University also offers technical Diploma programs through Polytechnics (08 Diplomas) and Vocational programs through Industrial Training Institutes (08 Trades). The University is evolving to deliver Innovative and Relevant Quality Education with flexible academic framework through Choice Based Credit System and upgrade the curriculum based-on market needs periodically.

## 1.5 Governance

Effective Governance System is in place for transparency and accountability with established structures. Further, the University is switching over to e-Governance functioning for streamlining of internal processes.

The University is also part of Mission Mode Directives of MoE such as *Swacch Bharat Abhiyan*; *Swacch Bharat - Swasth Bharat*; *SwatchhataPakhwada*; *Unnat Bharat Abhiyan*; *Ek Bharat - Shreshtha Bharat*; *BetiBachao – BetiPadao*; *VittiyaShaksharatAbhiyan* and *PM KaushalVikasYojana*; in addition to **Digital India** project **NKN - NME-ICT**, which includes *Campus Connect*, *UGC-INFLIBNRAT*, *NDL Cluster*, *SWAYAM*, *SWAYAM PRABHA*, *NAD*, *Bharatvanietc*.

## 1.6. Uniqueness

Academically, MANUU stands among the best Universities in the country offering educational programs in General, Professional, Technical and Vocational streams. It has received ‘A Grade’ accreditation by NAAC- in 2016 and re-accredited with ‘A+ Grade’ in 2022. The academic thrust of MANUU lies in its unique service of providing education from elementary to doctoral levels in the Urdu language. MANUU has carved a niche as one of the preferred destinations of higher education for academically marginalized section of the society.

There are 18 satellite and off-campuses of MANUU in 11 States across India. About 6,300 students are pursuing various programs in regular mode. The Directorate of Distance Education (DDE) offers various academic programs in distance mode thorough a network of 9 Regional and 5 Sub-Regional Centers and 157 Learners Support Centers catering to more than one lakh students at their door step. The University has campuses across the country viz, Three Industrial Training Institutes (ITIs) at

Hyderabad (Telangana), Bengaluru (Karnataka), and Darbhanga (Bihar); Five Polytechnics at Hyderabad (Telangana), Bengaluru (Karnataka), Darbhanga (Bihar), Kadapa (Andhra Pradesh) and Cuttack (Odisha).

These institutions will fulfill the objectives of the University of imparting vocational and technical subjects in Urdu medium. The University has Eight Colleges of Teacher Education at Srinagar (Jammu & Kashmir), Darbhanga (Bihar), Bhopal (Madhya Pradesh), Nuh (Haryana), Asansol (West Bengal), Sambhal (Uttar Pradesh), Aurangabad (Maharashtra), and Bidar (Karnataka), Varanasi (Uttar Pradesh) to train prospective teachers. The University also has satellite campus at Lucknow (Uttar Pradesh) offering UG, PG and Research programs. To address mission of empowering Women, the University established an

exclusive - College of Arts and Science at Budgam (J & K) offering post-graduate and research programs. True to its mission of spreading the wings of Urdu and instilling a passion for Urdu among the new generation learners, the University has also established three Model Schools at Hyderabad, Darbhanga and Nuh to provide quality school education in Urdu medium.

The University has several academic support centres such as Human Resource Development Centre (HRDC), Instructional Media Centre (IMC), Centre for Information Technology (CIT), Directorate of Translation and Publications (DTP), Directorate of Admissions (DoA) and Internal Quality Assurance Cell (IQAC) which provide value addition to the University.





The endeavour of MANUU in providing instruction, carrying out research and making contribution through the medium of Urdu has made it a trailblazer and trendsetting university in beaconing vast opportunities to all Indian languages institutions for tapping their potential to offer education in science & technology.

The MANUU clearly envisaged the need to enhance, enlarge and expand its activities that are relevant to the emerging economic environment of the country and also to fulfill the shortfall of workforce needs due to intensifying activities as per plan mandate of the UGC and also in tune with the directions of MoE with reference to quality education, research promotion, internal resource generation, infrastructure development, student centric measures, e-governance initiatives, outreach activities etc. Further, it adheres to National Agenda of Access, Equity and Quality and also to ensure that all the graduating students acquire an adequate knowledge of the English and Information Technology. This enables the Urdu medium students to compete with the rest of the students in the country for both the vertical and horizontal mobility.

- **Quality:** Considerable expansion in Infrastructure, Facilities and Quality Faculty in addition to engagement of Adjunct/Visiting/Guest Faculty etc., to minimize the Student-Teacher ratio.
- **Best Practices:** Student Empowerment through various Support Systems and Progression Measures;
- **Support Systems:** Hostel facility, Fee Concession through 'Earn while you Learn', Scholarships, Reservation & Relaxation in age and merit for Women and Persons with Disabilities etc.

### 2.0 School of Languages, Linguistics, and Indology

The School of Languages, Linguistics and Indology offers both Masters and PhD programmes in English, Urdu, Hindi, Arabic, Persian, and Translation Studies. It also offers PhD in Urdu Culture Studies through the CUCS and PhD in Comparative Literature and PG Diploma in Teaching English through the Department of English. FYUG BA Hon/Research programme and part-time programmes in Urdu, Hindi, Arabic, Persian, Pashto, Translation Studies, Turkish, Telugu, French, and Russian are also offered. The PhD and Masters programmes are offered at the Hyderabad, Lucknow, and Budgam campuses, while the BA programme is offered at the Hyderabad, Falaknuma, Bhopal, Varanasi, Lucknow, and Nuh campuses. The School is introducing PhD Sponsored/Self-Financed mode in Hindi offered by the Department of Hindi.

#### Department of Hindi

The Department promotes Hindi language and literature. The focus of the Department is on interdisciplinary approaches of studies and research in Hindi, Urdu, Dakhini Languages and culture. The Department offers UG programmes; M.A., Ph.D. and a part-time Diploma programme. The thrust areas of research in the Department are Feminist Literature, Dalit Literature, Medieval Poetry, Modern Literature Comparative Literature, Translation, Kathasahitya, Drama, Adivasi, Muslim Discourse and Modern Theatre.

The Mission of the School is to strive to create ethical, socially responsible and agile future business leaders. The SBCM is currently having one Department viz. Department of Management and Commerce.

#### Ph.D. Programme in Sponsored / Self-financing (Part time) Mode in Specialized field in Management & Commerce

The research program promotes innovation, focuses on activities that can make a difference to problems that matter to industry and society and has a business-friendly attitude to foster external collaborations. The Department's research focus is on various emerging areas of the Commerce and Management, but not limited to its conventional areas of specialization. The Department has well experienced faculty members with strong research and industry background. DMC provides highly supportive research environment that nurtures and develops future generations of young researchers. Admission to Ph.D. Programme in Sponsored / Self-financing (Part time) Mode in Management & Commerce Stream for the persons working in industry/Corporate Sector from the academic year 2022-23 onwards with a special fee sponsored by their employer.

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part time) Mode in Management the candidate has to fulfill the eligibility criteria mentioned i.e. 55% marks in MBA Degree / 2 Years PG Diploma in Business Management recognized by AICTE.

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part time) Mode in Commerce the candidate has to fulfill the eligibility criteria mentioned i.e., 55% marks in M.Com.

### 3.0 School of Sciences

The School has been offering UG programs in Mathematics, Physics, Chemistry, Botany, Computer Science and Zoology and a PG Program in Mathematics since 2014 and have adopted NEP program from academic year 2023-24 at UG level. Along with these regular programs, the School is also running Vocational courses at UG level (B.Voc. MLT & MIT) from the year 2019. From this academic year 2023-24 all the sections have started the PG programs i.e., M.Sc. (Botany, Chemistry, Physics & Zoology) and Vocational courses at PG level (M.Voc-MIT & MLT) in Self-financing Mode. From the year 2017 onwards all the Sections/Department were enrolling Regular Ph.D. students. Apart from regular mode, Ph.D. Program in Sponsored Self-financing (Part time) Mode was also introduced in all five subjects of Sciences in the year 2021-22.

The School is currently running five Ph.D. Programs: Mathematics, Physics, Chemistry, Botany, and Zoology and 7 PG Programmes: M.Sc. in Botany, Chemistry, Mathematics, Physics, Zoology, and M.Voc. (MLT and MIT) and UG Programmes: 4YUG in Science stream with Dual Major (Botany/Chemistry/ Mathematics/Physics/Zoology), B.Voc. (MLT), B.Voc. (MIT) and B.Voc.(ETT).



Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part time) Mode in Botany / Physics/ Chemistry the candidate has to fulfill the eligibility criteria mentioned i.e., 55% marks in Post Graduation in Botany / Physics/ Chemistry.

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part time) Mode in Zoology the candidate has to fulfill the eligibility criteria mentioned i.e., 55% marks in Post Graduation in Zoology / Life Science / Biochemistry / Biotechnology / Genetics.

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part time) Mode in Mathematics the candidate has to fulfill the eligibility criteria mentioned i.e., 55% marks in Post Graduation in Mathematics / Applied Mathematics.

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part time) Mode in Allied Health Sciences, the candidate has to fulfill the eligibility criteria mentioned i.e., 55% marks in Post Graduation in Medical Laboratory Sciences / Technology.

## 4.0 School of Technology

The School of Technology (formerly School of Computer Science and Information Technology), was established in 2014 with the objective to create a congenial environment for inspiring students, retaining outstanding teachers, providing quality teaching and developing cutting-edge technology for technological intervention. The School is currently having one Department viz., Department of Computer Science & Information Technology.

The School also comprises of five Polytechnics located at Hyderabad, Bengaluru, Darbhanga, Kadapa and Cuttack and three ITI's located at Hyderabad, Darbhanga and Bengaluru. Department of Computer Science and Information Technology was established in 2006 with the aim to impart quality education and achieve the vision of excellence in the field of Computer Science, IT and interdisciplinary research. Presently, Department of Computer Science and Information Technology offering B.Tech (Computer Science), M.Tech in Computer Science and MCA (two-years) programmes all approved by the All India Council for Technical Education (AICTE). Department also provide options of Lateral entry into second year of B.Tech. (Computer Science) for Polytechnic students.

The Department of Computer Science and Information Technology provides an excellent learning environment with dedicated young faculty members, state-of-the-art laboratories and innovative academic processes. We focus on providing an in-depth knowledge in the field of Artificial Intelligence, Personalized learning, Machine learning, Computational sustainability, Block chain technology, semantic web, internet of things (IoT) and other allied fields of computer science & IT. We aspire our students towards becoming next generation IT professionals capable of generating programming and logical skills, providing networking solutions and becoming leaders in software industry, government and academia.

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part-time) Mode the candidate has to fulfill the eligibility criteria mentioned below:

The following are eligible to seek admission to the Ph.D. programme in Computer Science:

i. Post-Graduation in Computer Science / Computer Applications / Information Technology / or related interdisciplinary branch of Computer Technology with 55% marks and the eligibility criteria prescribed in general guidelines.

OR

ii. 1-year/2-semester master's degree program in Computer Science / Computer Applications / Information Technology / or related interdisciplinary branch of Computer Technology after a 4-year/8-semester bachelor's degree program.

OR

iii. 2-year/4-semester master's degree program in Business Management with any branch of Computer Science or IT/ Data Analytics/ Electronics & Communication Engineering or related interdisciplinary branch of Computer Technology with 55% marks and the eligibility criteria prescribed in general guidelines after a 4-year bachelor's degree program in Computer Science / Information Technology.

OR

Qualifications declared equivalent to a master's degree by the relevant statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade on a point scale wherever a grading system is followed.

OR

iv. An equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency approved, recognized, or authorized by an authority established or incorporated under the law in its home country or by any other statutory authority in that country to assess, accredit, or assure the quality and standards of the educational institution.

- Provided that a candidate seeking admission after a 2-year/4-semester master's degree program in Business Management/ Electronics & Communication should have an experience of atleast five years in IT Industry.

- Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree program should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent



grade may be allowed for candidates belonging to SC/ST/OBC (non-creamy layer), Differently-Abled, Economically Weaker Section (EWS), and other categories as per the Commission's decision from time to time.

- Candidates who have completed the M.Phil. program with at least 55% marks in aggregate or its equivalent grade on a point scale wherever a grading system is followed, OR an equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency approved, recognized, or authorized by an authority established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit, or assure the quality and standards of educational institutions, shall be eligible for admission to the Ph.D. program.
- A relaxation of 5% marks or its equivalent grade may be allowed for candidates belonging to SC/ST/OBC (non-creamy layer), Differently-Abled, Economically Weaker Section (EWS), and other categories as per the Commission's decision from time to time.

#### **5.0 School of Education & Training**

The School of Education & Training was established in 2006. The objective of School of Education and Training is to prepare a community of excellent school teachers and teacher educators rooted in tradition and well equipped for future. The emphasis of the school is on the functional relationship between knowledge generation, theory development and effective practice through Urdu medium. The School of Education & Training is well equipped in terms of faculty and infrastructure. MANUU has focused on preparing teachers for Urdu medium schools since its inception. The first batch of D.Ed. Programme was started in 2001 followed by the establishment of the Department of Education and Training in 2004 with the addition of B.Ed. Programme in the same year. The Research Programme in Education was started in 2008 in the Department of Education and Training and it was later extended to CTEs.

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in Sponsored Self-Financing (Part-time) Mode in Education the candidate has to fulfill the following eligibility criteria:

55% marks in M.Ed. / M.A. Education with B.Ed. (55% Marks in both).

## 6.0 H.K. Sherwani Centre for Deccan Studies

The Maulana Azad National Urdu University established the H.K. ## 7.0 School of Arts and Social Sciences

The University has established the School of Arts and Social Sciences in the year 2005, to establish standards for educational programmes offered under Arts and Social Sciences. The main objective of the School is to offer programmes of study that influence the passion of human concerns for philosophical, social, political, economical, historical and public life and to play an important role in understanding the issues that deal with the society and gender. The School is currently having eight Departments and is the largest of all schools in the University and also offers programmes at satellite campuses at Lucknow (U.P.) and Srinagar (J & K).



## 7.1 Department of Political Science:

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. Programmes in a Sponsored Self-Financing (Part time) Mode the candidate has to fulfill the eligibility criteria mentioned i.e., 55% marks in M.A. Social Work.

## 7.3. Department of History:

The Department of History was established in 2014. The Department offers M.A. in History and Ph.D. programme. The Department has experienced teachers drawn from various reputed universities. The syllabi have been framed keeping in view the national interests, country's ethos, employability of students and objective of the University to promote women's development and other sections of the marginalized communities. It offers B.A, M.A and PhD in Public Administration. Four years B.A UG Programme under NEP 2020 has been started from the year 2023.

The Department prepares the students for academics, competitive exams, corporate sector and research. The focus is on the overall development of the students. The Department has a pool of talented and experienced staff. The faculty members have published books both in English and Urdu and a number of articles have been contributed to reputed Journals. #### 7.6. Department of Sociology:

Apart from the eligibility criteria prescribed in general guidelines to take admission in Ph.D. programmes in a sponsored self-financing (part-time) mode, the candidate has to fulfil the eligibility criteria mentioned, i.e., 55% marks in M.A. Sociology\* or any other allied/relevant subjects such as Social Anthropology, Gender Studies/Women's Studies, Social Exclusion and Inclusive Policies, Social Work, Social Medicine and Community Health, Development Studies/Rural Studies, Urban Studies/Public Policy, and Media and Communication Studies/Cultural Studies.

\* However, the preference shall be given to the students with a Master in Sociology.

## 9.0 MANUU Law School

The said programs provide candidates with the opportunity to equip themselves for active and effective participation, as professionals, in legal counseling, advocacy and decision-making. ## 10. General Instructions for Admissions into Ph.D. Programme in Sponsored / Self-financing (Part-time) Mode

1. There is no age bar (upper age limit) for admissions into Ph.D. programs.

### 2. Mode of Admissions:

(i) **Registration:** The University provides admissions based on the registration to the programs offered on the merit in the Research Admission Test (RAT) / RAT exempted category weightage and interview.

(ii) **Online Application Forms for Registration :**

(a) **Research Admission Test based Admissions:** The admissions in Ph.D. Sponsored / Self-financing (Part time) Programme are based on entrance test. The University website- <https://manuucoe.in/PTAdmission/> provides link for Registration and Application Form for admissions, January 2025. The candidates are advised to read the instructions carefully before filling the form and choose the correct program, Department, etc. and follow the instructions generated from the computer. The computer will generate application number (User name) and password which will be sent through *email* which needs to be saved for future reference.

(b) **Hall Tickets** for Research Admission Test based programs can be downloaded from the University Website. The candidates will be informed about receipt of their application form and date of availability of hall tickets through notification on website/email. Applicants can also verify the status of application form using their login id and password from the University website. **No hall tickets shall be sent by post. It is the responsibility of the candidate to download the hall tickets.** Please mention the valid mobile phone number and email for receiving the instructions from the University. Hall tickets will be issued to only those candidates whose duly filled application forms are found correct and complete with prescribed fee and other mandatory details. The candidates with these hall tickets must carry a valid photo ID as a proof for the purpose of verification and ruling out the possibility of impersonation. No candidate will be allowed to appear in the Research Admission Test without Hall Ticket and a valid photo ID proof.

- Please note that all those who apply may be issued Hall Tickets without verifying whether or not they satisfy the eligibility criterion for admission to a program. This will be finally verified at the time of counseling and admission, if selected. The candidates are therefore advised to go through the Prospectus carefully and judge their eligibility before submitting their application forms.
- Despite this caution, if the candidates do not meet the minimum eligibility criteria and still apply and appear for any program, they shall do so at their own risk and cost. At any stage, if it is found that any candidate does not fulfill the minimum eligibility requirements and other claims, his/her candidature will not be considered for admission and if the admission is granted, it shall be cancelled and fee paid, if any, will be forfeited. The University may initiate due legal action against such candidates.

(c) A candidate seeking admission in Ph.D. Programme in Sponsored / Self-financing (Part time) mode has to choose one of the emerging areas of research identified and notified by the department concerned. Candidates invited for interview for admission of Ph.D. Programme in Sponsored / Self-financing (Part time) mode programme are required to submit a research proposal in the identified area of research which will be evaluated by the Interview Board / DRC. For qualifying for admission all candidates have to secure 50% marks in the interview (RAT qualified and RAT exempted candidates).

(d) **Mode of Payment of Application Fee:** All fee payments are through online only using Debit Cards, Credit Cards and Internet Banking. Candidates have to follow the instructions given in online application form for Payment. No other forms of payment shall be accepted.

(e) Applicants need not send hard copy / printed application form to the University.



## 9.1 Admissions to Ph.D. Programme in Sponsored / Self-financing (Part time) mode

### 1. Qualifications:

Candidates seeking admission to the Ph.D. Programme in Sponsored / Self-financing (Part time) mode shall have a Master's degree in the concerned subject or an allied subject with at least 55% marks in aggregate or its equivalent grade in a point scale in case of grading system.

**Note:** “The qualification/eligibility may be decided/ amended time to time as per the approval of concerned School Board”.

### 2. General Eligibility:

The following categories of candidates shall be eligible for admission to the Ph.D. in Sponsored / Self-financing (Part time) Mode Programme on production of written permission from his / her employer:

Professionals such as working engineers, scientists, senior executives, managerial staff, self-employed entrepreneurs / startup promoters / innovators and academic administrators who can, while employed, attend regular classes as per schedule at MANUU may apply for admission to Ph.D. Sponsored / Self-financing (Part time) mode program subject to the following conditions:

- (i) Persons, who possess the minimum prescribed qualifications and are in service in any of the following establishments shall be eligible for admission to the Ph.D. Sponsored / Self-financing (Part time) mode as sponsored scholars:
  - a) Defense, Culture, Finance, Science & Technology, Education or other ministries of the Government of India or any other government organization;
  - b) Established industrial research and development organizations / corporates / museums / archives / research institutes / libraries;
  - c) Autonomous bodies and public undertakings;
  - d) CSIR/UGC/NCERT/ SCERT / State or Central Government Department or Ministry or Educational Entrepreneur / NGOs
  - e) University/Degree College Faculty.
  - f) Employees of Public Sector Undertakings or Government Departments or non-degree awarding Research and Development Organizations or reputed Private Industries/corporate bodies registered under Companies Act or Self-employed entrepreneurs from SMEs, Innovators or Start-ups promoters or Independent professional consultants are eligible for admission to self financed sponsored programmes;
- (ii) He/she should be a permanent/regular/full time employee and possess a minimum working experience of **3 years**. **Three years' full time relevant experience after obtaining the qualifying degree as on date of registration.**
- (iii) Sponsored/Self-financing candidates selected for admission in Ph.D. Sponsored/Self-financing (Part time) mode programme are not eligible for any scholarship from MANUU.
- (iv) For Sponsored/Self-financing candidates from outside the location of the University/ Institution (or at a radial distance of more than 50 km from university, there is a minimum residency requirement of 6 months. The respective Departmental Research Committee or Board of Studies may specify a higher residency requirement based on the courses recommended as well as the background. In such cases, he / she will be required to maintain frequent contact with the supervisor in the Department concerned of MANUU, Hyderabad.
- (v) Sponsored / Self-financing candidates are required to submit a “No Objection Certificate” (NOC) on a proper letterhead from the appropriate authority in the organization clearly stating the following:
  - a) the candidate is permitted to pursue studies on a part-time basis;
  - b) he / she will be fully relieved from duty for the period of required residency that is essential for completing the course work; provided if a candidate is working in organizations located within a distance of 50 km from the place of research (Hyderabad), he/she need not to take any leave;



- c) that his / her official duties allow him / her to attend the required classes (course work or special lectures or presentations etc.) as per the Time Table of MANUU at Hyderabad;
- d) that his services are likely to be retained with the employers during the period of studies;
- e) facilities for research in the candidate's field of research are available at the candidate's place of work; in case the proposed Ph. D. research plan requires him/her to use these facilities when the candidate is physically present at this place of work.

(vi) Any permanent employee with three years of regular service in any UGC/CSIR recognized Institution or Public Sector / Government / Non-Government Organization having adequate research facilities.

- a) The candidate must give an undertaking that he/she would take leave for a minimum of six months for attending the classes of the PhD course work.
- b) However, such candidates have to provide reasonable proof of fieldwork/lab work periodically to the satisfaction of the concerned Research Supervisor / Research Advisory Committee and may also be required to present the same before the Departmental Research Committee. Failure in this regard shall lead to cancellation of the PhD registration.

### 3. Additional requirements for Ph.D. Sponsored / Self-financing (Part time) mode Programme in Mode:

- i. recognized Public Sector / Research Institutions Government / aided or private establishments preferably have adequate research facilities;
- ii. A candidate sponsored by an industry, R&D Organisation, Educational Institution or a Government organisation having adequate research facilities may be allowed to work externally subject to his/her fulfilling all such conditions prescribed by the MANUU Ph.D. Regulations as are applicable.
- iii. Permission to carry out the research work partially or entirely at the Organization shall be granted only if the DRC concerned is satisfied about availability of research facilities at the workplace and fulfillment of all requirements and such permission is to be obtained in advance;
- iv. In such a case a co-supervisor from the sponsoring organization with adequate research experience may be appointed, if required, with the approval of the DRC concerned.
- v. When a sponsored candidate has been granted permission under these provisions to work externally at the parent Organization, he/she will be required to maintain frequent contact with the supervisor in the Department concerned of MANUU, Hyderabad.
- vi. There is no requirement of taking study leave from the organization to join the Ph.D. Programme under sponsored category provided his place of work is located within 50 km radius of the University campus/college campus where he/she is proposed to register for the research programme.
- vii. The University shall not provide hostel facility.

**Provided that all such candidates shall have to follow the admission, process and fulfill all other requirements as per the existing PhD Regulations.**

- 4. A candidate seeking admission as Sponsored / Self-financing (Part time) research scholar shall submit an assurance from the employer that the required leave of six months shall be sanctioned for the purpose stated, as an additional document at the time of registration. Without the permission letter from the employer the PhD admission shall not be granted.
- 5. Admission shall be made through **Research Admission Test** or Based on exempted category, followed by interview based on the research proposal submitted by the candidate concerned. Due Weightage will be given to candidates having quality research publications in reputed journals or accomplished research work in their respective field of studies in award of interview marks. The pattern of the Research Admission Test in Bilingual mode (Urdu/English) will be of 50 marks based on General Aptitude and Domain Subject



Knowledge (25 Marks each). RAT is to be conducted by one of the Dean's of the Schools offering the programmes by rotation.

6. **Duration:** The duration of the part-time Ph.D. programme shall be the same as in the case of regular Ph.D. programme i.e., for a minimum duration of three years, including course work and a maximum of six years (as per UGC Ph.D. Regulations, 2022) amended from time to time.
7. The Sponsored / Self-financing (Part time) mode research programme leading to Ph.D. will be offered by, School of Sciences, School of Technology, School of Education & Training, H.K. Sherwani Centre for Deccan Studies and School of Commerce and Business Management at MANUU Main Campus, Hyderabad.
8. **RAT Exempted Category:** Research Admission Test (RAT) will not be insisted for the following category of applicants' subject to fulfillment of other eligibility conditions:
  - (i) The following types of candidates shall also be exempted from RAT, on the recommendation of the Admission Committee with the approval of the DRC, provided they fulfill the requirements regarding eligibility, qualification, etc. However, such candidates shall have to give a seminar and discuss the broad area of research before the DRC:
    - (a) Candidates sponsored under an MoU between MANUU and an Industry / Corporate entity / Govt. or Non-Government organization / Agency where specific clause(s) exist for registration of candidates for Ph.D. degree by the university provided they possess at least three years of professional or research experience in the institution / industry concerned.  
or
    - (b) Scientists working in Research Laboratories either owned or managed by the Central/State Government or an Autonomous Research Institution of National Status with three years' experience in the Grade of Scientist B or above with evidence of research.  
or
    - (c) Senior working professional in corporate sector.

## 9.2 Reservation in Ph.D. in Sponsored / Self-financing (Part time) Mode Programme category admissions

- i. The University follows the reservation policies of the Government of India issued from time to time. To accommodate adequate representation of various categories of candidates as an inclusive policy. The applicants claiming any of these categories need to submit the valid proof of the caste/ tribe/ other reservation in the prescribed form issued by the competent authorities as per the Government of India norms at the time of admission, failing which applicant shall not be considered for admission.
- ii. Reservation for Admission shall be based on the criteria notified by the University, and the guidelines/norms in this regard issued by the UGC and other statutory bodies concerned, applicable to SC/ST/OBC/EWS (NCL) and certain other categories as per University norms.

### 9.3 Fee Payment and Refund Policy

- **Fee Payment:** The candidates selected for the programs shall be notified on the University website/informed through email about the fee details (as prescribed in the prospectus) and the procedure of payment at the time admission.
- **Fee Revision:** University reserves the right to revise the fee structure of any program during the course period.
- **Fee Refund Policy:** On cancellation, the fee paid will not be refunded under any circumstances.

### 9.4 Other Important Instructions for Admission

1. Incorrect/ incomplete Application Forms shall be rejected. Therefore, candidates are advised to read the prospectus carefully before filling and submitting the Application Forms.
2. The candidates are advised to take utmost care while filling the columns of Name and Date of Birth (as in 10<sup>th</sup>/matriculation/SSC or Equivalent).
3. The University has the right to reject the application and to cancel the admission of any candidate on valid reasons as per the norms of the University. All admissions are provisional; the University has the right to cancel the admission of any student at any point of time.
4. No Candidate is allowed to pursue two-degree programs (UG/PG) from any university and in any mode (regular / part time) simultaneously with the research programme.
5. If a candidate fails to complete admission formalities by the prescribed date, he/she shall forfeit his/her right to admission.
6. If any error or omission is detected in the information furnished by the candidate in the application form or if any document is found to be defective at the time of verification, or at any time even after the candidate is admitted, the candidate's admission shall stand canceled. Fee paid to the University shall not be refunded. University may initiate due legal action for cases of fraud.
7. If an applicant is an employee (public or private sector organization), he/she shall submit a certificate of leave along with 'No Objection Certificate', for the duration of the program from his/her employer at the time of admission.
8. Selected candidates are not allowed to complete admission formalities in absentia.
9. Students admitted in all programs shall abide by the rules notified by the University from time to time.
10. **Admission Test Model Papers:** The test will be only in multiple choice questions format. Answer sheet will be in the form of OMR sheet ([http://www.manuu.edu.in/Eng-Php/entrance\\_regular.php](http://www.manuu.edu.in/Eng-Php/entrance_regular.php)).
11. **Merit lists:** Merit list of candidates qualifying the entrance test and list of qualified candidates shall be displayed as per schedule on the Notice Boards of the Departments/Colleges/Centers and also on University website. Candidates shall also receive updates through notification on website/e-mail about their admissions if they are qualified/selected.
12. **Jurisdiction for Legal Matters:** All legal disputes shall be restricted to the **jurisdiction of the courts of Hyderabad only**.
13. **Refund of multiple payments:** In case of multiple successful transactions the candidate has to send an e mail to [admissionsregular@manuu.edu.in](mailto:admissionsregular@manuu.edu.in) with all details and copies of payment receipts within 2 weeks of payment. After due verification the refund process will be initiated.

### 10. Submission of Admission Form

1. The candidates are required to compulsorily go through the prospectus before filling up their application for admission.
2. Candidates are advised to carefully read and follow the **instructions provided online** during the Form Submission Process.



3. Incorrect/ incomplete application forms shall be rejected. Therefore, candidates are advised to read the prospectus carefully before filling and submitting the Application Form.
4. To register for admission candidates are required to use the online form available at MANUU Admission Portal.
5. The Online Form submission process consists of two-phases viz. -
  - a. **Candidate's Registration:** Entry of Basic Profile of the Candidate, and
  - b. **Application Submission:** Choosing of Program(s), Category and Submission of Application Fee described in the relevant Section of the Prospectus.
6. Before applying for admission, a candidate is advised to ensure his/her eligibility as per the criteria laid down in the prospectus.
7. Following information should be readily available with the candidate during the Registration process:
  - a. A valid e-mail ID and Mobile number. All future communication with the candidate will only be sent using candidate's registered email id and mobile number.
  - b. Scanned copy of candidate's colored passport size photograph (Maximum 100KB in size) in JPG/JPEG format with White Background.
  - c. Scanned copy of candidate's signature (Maximum 100 KB in size) in JPG/JPEG format.
  - d. Scanned copy of the certificate of Urdu taken as a subject or as a Medium in 10th/10+2 level or equivalent

8. Once the registration process is successfully completed the system will send an email/SMS bearing the **unique Registration Number and a verification code to verify the email id and mobile number.**
9. Registered candidate can access the admission portal using Registration Number as **login ID** and Verification Code as **Password**.
10. After successful login into admission portal candidate may proceed to apply for the program(s) of his/her choice and pay the application fee.
11. Application Fee should be remitted through **Online Mode** only using Credit Cards/ Debit Cards / Net Banking.
12. Candidates are advised to retain hard copy of the Application Form after the fee is paid successfully. Candidates need not send hard copy of the application to MANUU.


