



**Procedure for Conduct of Online Counselling of Bachelor of Legislative Law (LLB)**

1. The selected candidates have to upload the following certificates from 15<sup>th</sup> to 17<sup>th</sup> June, 2026 through their login credentials on the Admission portal <https://manuucoe.in/regularadmission/>
  - i. \*Proof of Urdu as a language/subject/medium at 10<sup>th</sup>/12<sup>th</sup> /Graduation or equivalent from Madarasa Board.
  - ii. \*Marks sheet of 10<sup>th</sup>/SSC/equivalent Board Examination.
  - iii. \*Marks sheet of 12<sup>th</sup> Board Examination.
  - iv. \* Marks sheets of all the semesters of the qualifying examination (Graduation) need to be merged.
  - v. Transfer Certificate (from the Institution last studied).
  - vi. Migration Certificate (from the Institution last studied).
  - vii. \*Valid Category Certificates OBC/EWS/SC/ST/PWD (format prescribed by Government of India) if applicable.
  - viii. \*Valid Supernumerary Quota Certificate (ECA / NSS / NCC / Sports / Children of Armed Personnel / Kashmiri Migrant / MANUU Staff Quota / Hyderabad Local Quota) if applicable.
  - ix. \*Valid Special Category Certificate (MANUU Model School Students) if applicable.
  - x. Bonafide / Character Certificate (from the institution last studied).

**Note: \* Mandatory as relevant.**

2. While uploading the certificates, selected candidates are required to update their mobile number and email through which they could be contacted.
3. The **Certificate verification** will be taken up by concerned Departments. The candidates are required to be alert and available to respond for any clarification sought by the Department Verification team from **10 am to 5:30 pm** on **18<sup>th</sup> June, 2026**.
4. In case of non mandatory certificates time would be given for submission till **15<sup>th</sup> July, 2026**.
5. If all certificates are in order and the verification team approves for provisional admission, then you will receive an SMS or email to proceed for fee payment.
6. To complete the admission process, again login to your admission portal and pay the required admission fee. **The last date of fee payment is 19<sup>th</sup> June, 2026**.
7. In case the verification team finds that the candidate is not eligible, he/she will receive an SMS or email indicating the reason for ineligibility.
