Terms and Conditions

1. The work shall be executed as per original manufacturers' specifications and as per the standards and specifications laid down under the Bureau of Indian Standards, CPWD specifications latest. Where the aforesaid provisions and conditions are silent, relevant specialized literature and manufacturer's specification shall be followed for execution of work.
2. The Earnest Money in the form of Demand Draft or Banker's Cheque or Fixed Deposit Receipt, etc., drawn in favour of Finance Officer, MANUU, Hyderabad shall be scanned and uploaded to the e-tendering website(CPPP) within the period of bid submission. The original EMD should be deposited in the office of Executive Engineer, MANUU within the period of bid submission. The Executive Engineer shall issue a receipt of deposition of Earnest Money deposit to the bidder in a prescribed format.
3. Before tendering, the contractor shall inspect the water coolers at site of work and shall fully acquaint himself about the conditions prevailing at site, availability of materials in market, availability of ready site and suitable locations for execution of the work involved in achieving the completion of work.
4. The contractor shall at his own expense and risk arrange the storage of materials at site of the work for carrying out of all jobs connected with the completion of the work. The contractor shall have to abide by the regulations of the authorities concerned and the directions of the Executive Engineer. If during construction, it becomes necessary to remove or shift the equipment, material, etc, to facilitate execution, the contractor shall carry out the removal of shifting as directed by the Executive Engineer and re-shift to its original position and no claim whatsoever, shall be entertained on this account.
5. It shall be deemed that the contractor has satisfied himself as to the nature and location of the work, transport facilities, availability of site, etc. the department will bear no responsibility for lack of such knowledge & the consequences thereof.
6. The Executive Engineer shall have full powers for removal of any or all of the materials brought to site by contractor which are not in accordance with the contract specifications or do not conform, in character or quality. In case of default on the part of the contractor in removing rejected materials, the Officer-in-charge shall be at liberty to have them removed at the risk and cost of the contractor.
7. The work shall be carried out in such a manner so as not to interfere / or adversely / or disturb the functioning of the University and other works being executed by other agencies, if any.
8. Any damage done by the contractor to any existing work or work being executed by other agencies shall be made good by him at his own cost.
9. The contractor shall maintain in good condition all work executed till the completion of entire work entrusted to the contract under this contract.
10. No payment shall be made to the contractor for damage caused by rain, flood and other natural calamities whatsoever during the execution of works and any damage to the work on this account shall have to be made good by the contractor at his own cost.
11. The Contractor shall take instructions from the Executive Engineer regarding collections and stacking of materials at site.
12. The Contractor shall be responsible to arrange at his own cost all necessary tools and tackles required for execution of the works including incidental original and maintenance works.
13. The operating cost of contractor's machinery at site i.e. Coolants/ lubricants/ Petrol/ Kerosene Oil/ Mobile Oil/ etc, if any shall be borne by the contractor himself.

14. The University shall not be responsible for any injury partial or permanent or death of any workers at site due to accident or malfunctioning of the equipment or by negligence of the Contractors staff on site.
15. All applicable and prevailing taxes will be recovered from the bills as applicable from time to time.
16. If any damage caused for public conveniences/ services, the same shall have to be repaired instant, failing which necessary recovery shall be make from the bill.
17. If any Building, Road and Channels will be damaged by the Contractor the same will have to repair by the Contractor at his risk and cost, otherwise the complete cost will be recovered as intimated by the Engineer-in-charge.
18. Validity of the quotation should be at least 30 days.
19. Price should be inclusive of all (transportation up to MANUU, Gachibowli and all other incidental expenditure, if any).
20. Price of the items, GST% should be indicated separately as per CPP portal.
21. No advance payment will be made.
22. Verbal quotation or incomplete quotation will be rejected.
23. Any variation in the specification(s) during repair/servicing will be rejected.
24. Time allowed 10 days and starts from the date of issue of Work Order
25. The repair and rectification work shall be carried out to make the equipment operational to the entire satisfaction of the Executive Engineer.
26. Payment shall be made on submission of Invoice after satisfactory execution of the work.
27. The rates quoted are net and nothing extra shall be paid on any account.
28. The tax as applicable shall be deducted from the gross amount of the bill.
