- b. The concern Section Head shall submit the Physical Verification Report duly signed by the Committee (as per the approved committees mentioned in this circular) members. A quorum of three members i.e. Section Head and other two officials are mandatory for submitting Physical Verification Report.
- c. The Physical Verification Committee shall check each item listed in the Inventory Software and also certify its status alongwith the serial number(s). Discrepancies, if any, shall be promptly investigated and brought to account.
- d. Any query / clarification during Physical Verification Process, shall be addressed to physicalverification@manuu.edu.in
