It is to notify that the "COVID-19 Pandemic Monitoring Task Force & Committee for Re-opening of University in Phased Manner" has recommended to start the academic activities through offline mode only for all MANUU regular students with effect from 01.03.2022 for all AICTE/NCTE/continuing programmes and for other programmes including Ph.D. programme w.e.f. 08.03.2022.

Therefore, all the regular students of MANUU are instructed to return to the university campus as per the dates mentioned above with reference to the academic calendar issued vide notification No.MANUU/Acad/F.139/2021-22/159 dated: 23.09.2021.

Further, Hostel Boarders shall submit their final COVID-19 Vaccination Certificate at the concerned Provost Office, whereas Non boarders shall submit the final COVID-19 Vaccination Certificate at the office of concerned Heads of the Departments/Principals. All the students (boarders and non-boarders) shall have to strictly adhere to the Covid appropriate norms in the campus. All the students should wear mask on campus and in classrooms compulsorily.

With regard to other MANUU Off-campuses (Satellite Campuses / CTEs / Polytechnics /ITIs/ Model Schools), the Principal/In-charge of the respective Off-Campuses shall also follow this notification. However, they also have to follow the guidelines issued by the respective state governments in this regard and intimate the same to the committee.
