CIRCULAR

In continuation to the circular vide No.MANUU/DSW/F.65/2020-21/1250 dated 24th March, 2021, it is to state that in view of the prevailing situation in the rise of Covid-19 cases in different states across the country, it is directed that all campuses should take appropriate measures in order to prevent and contain the rising cases with reference to MHA order dated 23rd March, 2021.

As per the GO issued by the Govt. of Telangana dated 23rd March, 2021 to close down all educational institutions in the state and continue teaching-learning process through online mode only, it is directed that MANUU Model School, Falaknumua in Hyderabad should follow the guidelines and continue the teaching learning process through online mode only.

It is reiterated that teaching in Hyderabad campus will also continue through online mode only till further orders in view of the referred GO. All the Heads of the Departments are requested to fix staggered timings as per requirements for teaching faculty to attend the emergent work, with all the precautions, related to the Departments, Examinations and Research Scholars, if any. It is mandatory for all to strictly follow COVID-19 guidelines issued by the concerned State Government, Government of India and UGC from time to time.

Further, the Head of the Sections are directed for staggering of work/business hours for the Non-Teaching staff in their respective sections at Headquarters, Satellite Campuses, Regional Centres and Sub Regional Centres with all the precautionary measures and to follow the directions annexed to the orders of the MHA vide No.40-3/2020-DM-I(A) dated 23rd March, 2021.

Moreover, Satellite campuses/Off-Campus are directed to adhere the State/UT Government Orders with the approval of the Competent Authority and continue the educational activities online till further orders.
