## Notice

Dear Boarders,

In compliance to notification issued by the Telangana Government and Ministry of Home Affairs (MHA) through its orders No. G.O.Ms. No. 67 and No. 40-3/2020-DM-I (A) dated 23<sup>rd</sup> March, 2021, the University has suspended all academic activities through 'Offline', as per circular No. MANUU/DSW/F.65/2020-21/250 dated 24<sup>th</sup> March, 2021.

In view of the directives and students safety and preventive measure, the boarders of the Hostels are advised to leave their native places due to upsurge cases of COVID-19 in Telangana State.

However, the boarders of the Hostels who may unable to leave the Hostel may continue to stay at hostels, after submitting an '**Undertaking cum consent of Parents/Guardian**' by 30<sup>th</sup> March, 2021 till 05.00 pm. The boarders can obtain the copy of the '**Undertaking cum consent of Parents/Guardian**' from Hostel Caretakers of the respective Hostels. **But they should try and leave the Hostel as early as possible, as it is in their interest. They should note that they are staying in Hostels on their own risks.**

However, due to present scenario/situation of COVID-19 Pandemic in Telangana State, the boarders are instructed to confine to their Hostel rooms/Hostel premises. The boarders who are permitted to stay in the Hostels after submitting the '**Undertaking cum consent of Parents/Guardian**' will not be allowed to visit the Departments/Offices or outside of the Campus till the situation of COVID-19 normalizes or further directives received from Government of Telangana/India and the Universities authorities.

**Note:** The Ph.D research scholars of final year who are about to submit their thesis within six months and Ph.D research scholars of 'School of Sciences' which requires mandatory wet laboratories work may submit the '**Consent of the Supervisor/HOD**' from their respective Department in the desired format available at Hostel Warden's/Caretaker's Office. However, said research scholars are not allowed to visit other Hostels/other Departments/residential area of the staff quarters in the campus **except Reading Room, University Library / concerned research laboratories in the Campus.**
