TERMS & CONDITIONS FOR THE USE & SUPPLY OF AUDIO VISUAL MATERIAL / FOOTAGE OF IMC, MANUU & OTHER MATERIAL AS MENTIONED AT FORM-B

Audio Visual material will be supplied by the Instructional Media Centre (hereinafter called the IMC, MANUU) only on receipt of a signed application (in duplicate) prescribed for the purpose.

- 2 (a) Application for stock footage of less than 20 Secs. in length will not be entertained;
 - (b) If footage/sound exceeding 300 Secs. are required for any one film production either at a time or on various occasions, special conditions may be prescribed.
 - (c) Digital tape (Hard disk/DVC PRO/Digi Beta etc) should be brought by the applicant for transfer of material.
 - (d) Processing Fee charges would be Rs. 1,000/- for the Audio Visual material transfer from one film.
 - (e) At the time of transfer of footage, the applicant should give in writing (on Letter Head) that, the footage purchased by them is _____sec. (with/without sound) and it will be for one time use only.
 - (f) If after selection of footage due to some reasons the applicant wishes to cancel the order, a letter should be given on their letter head with a valid reason. Amount paid for transferring material will not be refunded.
- 3. The Audio Visual material will be transferred in digital format only on receipt of full payment in advance by DD in favour of Director, Instructional Media Centre.
- 4. The IMC, MANUU reserves the right to refuse sale of any Audio Visual material required by an applicant without assigning any reasons whatsoever.
- 5. The Copyright of the Audio-Visual material remains vested in the IMC, MANUU and the Audio Visual material supplied shall be used by applicant only in the production mentioned in the application. The footages are not to be re-sold / loaned / transferred / disposed off or used for any other production or in any other manner what so ever.
- 6. The Audio-Visual material once sold will not be taken back by the IMC, MANUU for any reason what-soever, nor will the cost be refunded. No refund will be given in cases where the Audio-Visual materials have been ordered but delivery has not been taken of by the applicants.
- 7. The Audio-Visual material will be supplied at the rates prescribed from time to time.
- 8. The IMC, MANUU reserves the rights to change, modify or alter any of the condition(s) at their discretion without assigning any reason thereof.

- 13. Telecast right for full length MANUU film are only for 02 years & non-exclusive only for 2 telecast (one original & one repeat). Films / Programmes procured are not permitted to telecast on Social Media.
- **14.** Full length programme / film purchased should be telecast as IMC's film only and not to be used as stockshots for other productions / programmes.
- **15.** Transfer charges and Tape cost to be borne by the broadcaster / purchasers.
- 16. The broadcaster / purchaser should bring own blank tape of required space for transfer of footage / film.
- 17. DVD's for home viewing / Archival purpose can only be utilised as mentioned in Form -1.
- **18.** Film purchased for Telecast can only be used as per conditions mentioned at Form -3.
- **19.** Applicant needs to submit the Utlisation Certificate in given format, soon after the Audio-Visual material is procured.

PROCEDURE FOR SUPPLY OF STOCK FOOTAGE / AUDIO-VISUAL MATERIAL

On receipt of the application (which is to be submitted to the Director, IMC, MANUU, the IMC, MANUU will search for the Audio Visual material and inform the applicant about its availability. Within seven days of receipt of this information, the applicant may contact Director, IMC, MANUU, for selection of shots (this should be done by prior appointment so that the material can be kept ready). For purpose of selection, DVD will be shown on the monitor with Rs. 1000/- per film as processing fee. After the Audio Visual material is threaded / identified, the applicant will have to pay the cost of Audio-Visual material at the prescribed rates within three days, so that the Audio Visual material is kept ready. In case of transfer on digital format the applicant may get the same done at his/her cost. If the cost of Audio-Visual material is not paid within the time limit mentioned above or within the extended date (if agreed to by the IMC, MANUU), it will be presumed that the applicant is not interested in acquiring the Audio-Visual material. In case the purchase of Audio-Visual material is cancelled by the applicant after processing the file, a letter of cancellation should be given by the applicant.
