
In the order 2nd cited, Dr. Mohd. Shujath Ali, Deputy Director, CPDUMT was removed from the services of MANUU with effect from 11.05.2015.

2) Whereas, having aggrieved with the removal order of the University, Dr. Mohd. Shujath Ali filed a Writ Petition No. 14811 of 2015 before the Hon'ble High Court of A.P and Telangana.

3) The Hon'ble High Court in its order dated 16.12.2015 in W.P.No.14811 of 2015 filed by Dr.Mohd. Shujath Ali set aside the removal order of the University dated 11.05.2015. The Hon'ble High Court ordered that having regard to the fact that petitioner is deemed to be under suspension from the date of removal. The subsistence allowance payable to the petitioner from the date of removal shall be released forthwith.

4) In the light of the orders of the Hon'ble High Court, Dr.Mohd.Shujath Ali is deemed to be under suspension from the date of removal from service i.e. 11.05.2015. In compliance to the orders of the Hon'ble High Court, Dr.Mohd. Shujath Ali (Under Suspension) has been sanctioned Subsistence Allowance under FR 53 (1) of an amount equal to leave salary on Half Pay with appropriate Dearness and Compensatory Allowances for a period from 01.05.2015 until a final decision is taken by the Executive Council of the University in the matter.

5) The Subsistence allowance shall be paid only if the suspended official furnishes a certificate {under FR 52 (2)} that he was not engaged in any other employment, business, profession etc.
