

The Maulana Azad National Urdu University (MANUU), Hyderabad (Central University established by an Act of Parliament in 1998) intends to procure (Full HD Portable Live Switcher with Six Input Channel) for IMC, Gachibowli, Hyderabad from the prospective bidders. The intended bidders may furnish their quotations (as per the specifications mentioned below) online through Central Public Procurement Portal (CPPP) @https://eprocure.gov.in/eprocure. The online bids along with EMD for Rs.16000/- drawn in favour of Finance Officer, MANUU, Hyderabad (Exemption as per GoI norms will only be considered on production of documentary proof, failing which the bid will be rejected) shall be furnished as per the proforma prescribed (Annexure-2). The bid documents (both Technical bid and financial bid) along with the scanned copy of EMD proof may have to be upload online on CPP Portal on or before .18.11:2020... 2020 by 3.00 pm. However, the original EMD document/DD shall be submitted at Purchase & Stores Section before closing date of the bid.

1. Submission of Bids:

- 1.1 The technical and financial bids should be furnished in Annexure-I and Annexure-II respectively and both the bids should be submitted through online only along with the requisite documents.
- 1.2 Conditional and incomplete bids will be rejected summarily.
- The bids must be submitted before due date and time. 1.3
- Modification and Withdrawal of Bids: The bidder may modify or withdraw his bid 1.4 through online before last date for submission of the Bids.
- No tender will be accepted after the date of opening and time as specified in the tender 1.5 enquiry for any other reasons.
- 1.6 The bidders shall have to ascertain the exact percentage of GST applicable on each of the items while quoting the rates in the financial bid (Annexure-2). In case of discrepancy/difference of opinion on GST rates, the University shall decide the lowest quotation on verification of the relevant rules of the GST Act vis-à-vis supporting documents provided by the bidders in respect of the claim for the GST. The decision of the University shall be final and binding in this regard.
- The University reserves all the rights to place the award of Contract with the firm 1.7 quoting L-1 rates. In case, if two or more number of firms quotes the same rate, then the L1 will be decided based on the additional Warranty offered (if any). Even then, if there is tie between bidders, separate sealed quotation will be obtained with short notice from such bidders.

2. Submission of EMD

- The firms should submit EMD of Rs.16000/- in the form of Demand Draft / Bank 2.1 Guarantee / Fixed Deposit drawn in favour of Finance Officer, MANUU payable at Hyderabad in original by post or by hand. Scanned copy of EMD should be uploaded along with Technical bid document. Exemption as per govt. norms will be considered on production of documentary proof.
- The EMD of the unsuccessful bidders will be returned within 60 days after closing date of 2.2 the bid or within 30 days after finalizing the bid without interest. The EMD of the successful bidder will be returned on submission of Performance Security.

3. Opening of Bids

- Technical bid would be opened online only and scrutinized as per the eligibility criteria 3.1 prescribed.
- Financial bids of only technically qualified bidders will be opened by the authorized 3.2 officers of the University.
- The bidder must provide the services as per the specifications mentioned in the tender. 3.3 The firms may also quote for higher specifications. However, the criteria for requirement would be based on the actual specifications mentioned in this tender document.

Prices are to be quoted both in figures through online only. Amount quoted as '0' (zero) 3.4 in the financial bid will be treated as non-responsive and next L1 figures will be considered. In case of a discrepancy, quoted amount in words/lowest amount will be taken as valid. The quotation should be valid for a minimum period of 75 days from the closing date of tender.

4. Pre-qualification (eligibility) criteria:

- The bidder should be a registered firm / supplier with GSTIN. 4.1
- 4.2 The firm should submit an EMD of Rs.16,000/-
- The firm should submit the OEM Certificate or authorization certificate specific to this 4.3 tender.
- The firm should submit compliance report with respect to specification and warranty 4.4 etc. any deviation of quality will be summarily rejected.
- The bidder must upload Annexure I duly filled in. 4.5
- A) The bidder must have achieved the minimum average annual turnover of 4.6 Rs.2,56,000/- on supply of the similar items during the last three financial years.

5. Job Requirement

- Supply of Full HD Portable Live Switcher with Six Input Channel for Instructional 5.1 Media Centre, MANUU, Hyderabad.
- The quantity included in the bid can be increased or decreased at the discretion of the 5.2 Competent Authority, Maulana Azad National Urdu University Hyderabad, while issuing the purchase order. The University reserves the right to issue supplementary purchase order upto 25% of the bid value within three months from the date of Award of Contract on the same price and terms & conditions.

6. Delivery & Payment:

- The supply of said items has to be made within a period of 30 days from the date of award 6.1 of contract (AOC).
 - Failure to supply the material within the stipulated period shall entitle the Procuring Entity (MANUU) for imposition of penalty @ 1/2% (half percent) per day on the total value of the item covered in the purchase order, subject to a maximum of 5% (five percent) after expiry of the stipulated time period of the supply unless extension is obtained in writing from the office on valid ground before expiry of delivery period.
 - ii) If the deliveries are not maintained and due to that account Procuring Entity is forced to buy the material at your risk and cost from elsewhere, the loss or damage that may be sustained thereby would be recovered from the defaulting supplier.




