Maulana Azad National Urdu University (MANUU) is a central university under the aegis of Ministry of Education, Govt. of India. MANUU is willing to install Multi-operator Mobile Towers to improve the Mobile Network connectivity in the campus located at Gachibowli, Hyderabad.

Therefore EOI is invited from the Licensed/Authorized Telecom Infrastructure Companies and Mobile Operators of BSNL/ Bharti/ Airtel/ Vodafone- Idea/ Reliance Jio etc to conduct the survey to suggest number and type of Mobile Tower(s) to be installed for uniform Mobile Connectivity in the Campus.

Detailed terms of conditions: -

- 1) The Company should have Authorization/License from (DOT) Department of Telecommunications, Govt. of India., / The Telecom Regulatory Authority of India (TRAI) to provide solution/ Install tower as per the GOI Guidelines.
- 2) The Company should have authorization letter from the major mobile operator such as BSNL, Bharti Airtel/Vodafone-Idea/Reliance Jio etc.
- 3) No payment shall be made to the agency for conducting the survey.
- 4) The Agency has to share the survey report with the MANUU free of cost.
- 5) Mere conducting the survey will not make company entitle to claim for installation of Mobile Tower within the campus.
- 6) University will obtain financial Bids for installation of Multi-operator Mobile Towers within the campus on monthly rental basis based on the report submitted by the firms and approved by the competent authority of MANUU.
- 7) The Company will make written request to E.E (CIVIL.) MANUU along with the details of staff engaged & time required for conducting survey.
- 8) The Agency shall take all necessary measures for safety of the staff during the survey. However MANUU shall not be responsible for any untoward incident/accident caused due to any reasons whatsoever during the survey.
- 9) The Survey report should be submitted to MANUU within 3 days alongwith location & detailed drawings/Design/Specification etc for the Proposed Tower(s) by the Company.
- 10) The monthly rent with yearly Escalation 5%. Lease period will be 10 years and extendable upon mutual agreement. Security Deposit equal to 3 months rent.
- 11) Notice Period 3 months from either party with a valid reason.
- 12) Kindly submit the proposal to the Office of the Director, CIT on or before 10-11-2022 at 11:30 A.M.
