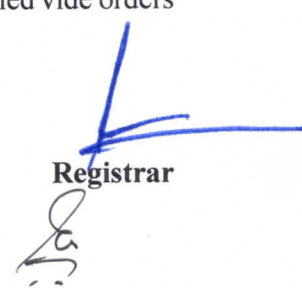

2. Terms of Reference:

- a. *The Building Committee shall be responsible for finalising the plans and estimates of the various building projects proposed to the Ministry of Education/Govt. of India and for ensuring completion of the Buildings and recommend the proposals and budget estimates for new constructions, extensions and renovation works of the university in accordance with the approved plans and estimates.*
 - b. *Utilisation of the funds received from the University Grants Commission/Ministry of Education, Govt. of India and from the own resources of the university.*
 - c. *Exercise all such powers as delegated to it by Executive Council from time to time; and*
 - d. *Constitute one or more Committees to look after any of the functions and responsibilities assigned to it.*
3. The Committee shall meet at least twice in a year, or as and when necessary.
 4. 50% of the members of the Building Committee shall form the quorum for holding meeting of the Building Committee. However, presence of the at least two Engineers and one Architect is must.
 5. TA/DA for members attending the meeting shall be paid as per the rules of the university.
 6. The term of the Committee shall be for a period of two years as notified vide orders 1st cited.
