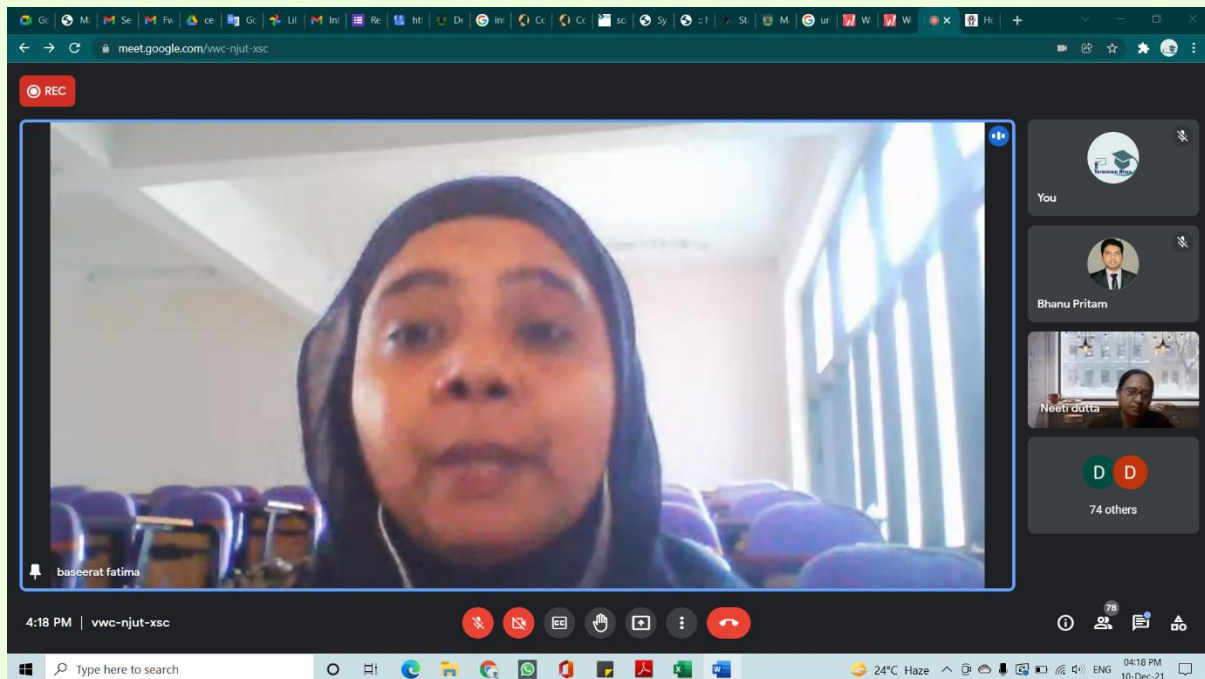

She finally advised to integrate the legal awareness into the curriculum of higher education in general and teacher education in particular with all her support for such future endeavour.
